HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

THURSDAY, 13 APRIL 1972

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr J. M. Fraser (Minister for Education and Science), Mr D. M. Cameron, Mr Jacobi, Mr Everingham, Mr Nicholls and Mr Webb each presented a petition from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
 - Mr Calwell, Mr Street, Mr Klugman, Mr Cass and Mr Jenkins each presented a petition from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
 - Mr L. F. Bowen presented a petition from certain electors of the Division of Kingsford-Smith praying that (1) the curfew between 11 p.m. and 6 a.m. at Sydney (Kingsford-Smith) Airport be rigidly enforced, (2) the use of Electra aircraft and/or jet aircraft be prohibited within the curfew hours, (3) concessional airport charges be granted to encourage aircraft operators to use their aircraft during normal business hours and (4) a social survey be taken of the area surrounding the Airport to indicate the magnitude of unrest and disturbance attributable to aircraft noise.

Petitions severally received.

Mr Cass also presented a petition from certain citizens of the Commonwealth praying that the House will appoint a nominee of the Craft Council of Australia to the Federal Government committee investigating the role of crafts as an art form.

Petition received and read.

Mr Klugman, Mr Armitage and Mr Luchetti each presented a petition from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.

Petitions severally received.

- 3 MINISTERIAL ARRANGEMENTS: Mr McMahon (Prime Minister) informed the House that, during the forthcoming absence abroad of Mr Anthony (Minister for Trade and Industry), Mr Nixon (Minister for Shipping and Transport) would act as Minister for Trade and Industry.

- .5 NON-PAYMENT OF UNEMPLOYMENT BENEFITS—STATEMENT BY MEMBER: Mr Daly, by leave, made a statement relating to an answer given earlier this day by Mr Wentworth (Minister for Social Services) to a question without notice concerning the nonpayment of unemployment benefits in certain circumstances associated with strikes.

Mr Kennedy asked leave to make a statement in connection with the matter.

Mr Scholes asked leave to make a statement in connection with the matter.
