THE PARLIAMENT OF THE COMMONWEALTH OF AUSTRALIA

HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS No. 175

THURSDAY, 18 MAY 1972

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: The Acting Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Hamer, Mr L. K. Johnson, Mr Scholes, Mr Staley, Mr Webb and Mr Whittorn —from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
 - Mr Bennett—from certain citizens of Western Australia praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.
 - Mr Buchanan—from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
 - Mr Bennett—from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which leads to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention and rehabilitation of criminals and (4) compensation to victims of crimes of violence.
 - Mr Keating—from certain employees of the Australian aircraft industry and citizens of the Commonwealth praying that the Government will assist the Australian aircraft industry with respect to aircraft purchases, spares, military equipment exports, and participation in aero-space projects.
 - Mr Bennett—from certain residents of Western Australia praying that this House take immediate steps to ensure provision of funds to provide for the all-weather sealing of the Eyre Highway.
 - Mr Armitage—from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.
 - Mr Bennett—from certain citizens of Australia praying that this House take immediate steps to ensure that protection is given to the residents of Aged Persons Establishments.

Mr Bennett—from certain residents of Western Australia praying that action be taken to move the Perth Airport from its present site.
