THURSDAY, 25 MAY 1972

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Chipp (Minister for Customs and Excise), Mr J. F. Cairns, Mr Cross, Mr Graham, Mr Jacobi, Mr Jarman, Mr L. R. Johnson, Mr Kennedy, Mr Keogh, Mr Pettitt and Mr Webb—from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
 - Mr Fairbairn (Minister for Defence), Mr Lynch (Minister for Labour and National Service) and Mr Grassby—from certain citizens of the Commonwealth praying that the Government will take cognisance of the serious financial difficulty facing the Australian tourist industry and give the industry financial aid in the forth-coming Budget.
 - Mr England, Mr L. R. Johnson and Mr Kennedy—from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
 - Mr Whitlam (Leader of the Opposition)—from certain citizens of Australia praying that this House will take immediate steps to reduce sales tax on cosmetics and toiletries from the present 27½ per cent to the "general rate" of 15 per cent.
 - Mr Bennett—from certain residents of Western Australia praying that this House take immediate steps to ensure provision of funds to provide for the all-weather sealing of the Eyre Highway.
 - Mr Staley—from certain electors of the Commonwealth praying that the Government produce and provide ultrasonic aids for the blind on the same terms as hearing aids for children, pensioners and others or, alternatively, that organizations struggling to manufacture and provide these aids be approved for subsidy under the States Grants (Paramedical Services) Act.
 - Mr L. R. Johnson—from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
 - Mr Keating—from certain employees of the Australian aircraft industry and citizens of the Commonwealth praying that the Government will assist the Australian aircraft industry with respect to aircraft purchases, spares, military equipment exports, and participation in aero-space projects.
 - Mr Griffiths—from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
