WEDNESDAY, 13 SEPTEMBER 1972

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Howson (Minister for the Environment, Aborigines and the Arts), Mr Brown, Mr Calwell, Mr Garrick, Mr Jarman and Mr Klugman—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972-73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
 - Mr Everingham and Mr Fulton—from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
 - Mr Bennett—from certain residents of Western Australia praying that the Government give urgent consideration to the return of land, compulsorily acquired from the Shire of Belmont for defence purposes, so that proper planning and development of the Shire can continue.
 - Mr Bennett—from certain residents of Western Australia praying that the House will take immediate steps to grant taxation concessions to mothers who are forced to pay fees to have their children retained in day care and family care centres.
 - Mr Bennett—from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of official programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.
 - Mr Brown—from certain citizens of Australia praying that the House will take immediate steps to ensure that State education is given a higher priority in the allocation of Federal funds and that emergency action be taken to solve the present acute shortage of teachers in the secondary teaching service.
 - Mr Enderby—from certain employees in Parliament House, Canberra, praying that an early decision will be taken by the Government to build the new and permanent Parliament House which will, in the long run, be a more economical way to house the Parliament and which will at the same time be an impressive and proud symbol of Australia's progress and national unity.
 - Mr Garrick—from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.

- Mr Klugman—from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.
- Mr Solomon—from certain citizens of Australia praying that this House will, in regard to the use of Commonwealth funds to aid church schools, restore to the Australian people true religious freedom which can exist only when Church and State are legally separated both in form and substance.
- Mr Uren—from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
- Mr Uren—from certain electors of New South Wales praying that this House will immediately make a substantial federal emergency grant to all State Governments for education services and carry out a public national survey to determine needs of the States after 1975.

Where there have been two or more publications in the Gazette of forms of words being, purporting to be, or apparently intended to be, notices or notifications of a kind referred to in the last preceding sub-section in relation to the same Ordinance, regulations, rules, by-laws or instrument, that sub-section applies only in relation to the earlier or earliest of those publications.".

Clause, as amended, agreed to.

Proposed new clause—

Mr Enderby moved—That the following new clause be added to the Bill:

"4. Nothing in this Act affects in any way the rights and liabilities Rights and in civil and criminal law of persons charged with offences arising diabilities of certain out of incidents outside Parliament House, Canberra on Thursday, persons.

20 July 1972 and Sunday, 23 July 1972 where those charges or incidents arise out of or are related to the purported notification in the Gazette of 20 July 1972 of the Trespass on Commonwealth Lands Ordinance 1972.".

Debate adjourned (Mr Jones), and the resumption of the debate made an order of the day for the next sitting.

- 17 POSTPONEMENT OF ORDERS OF THE DAY: Ordered—That orders of the day Nos. 1 and 2, government business, be postponed until a later hour this day.
- 18 CUSTOMS TARIFF PROPOSALS NO. 15 (1972): The order of the day having been read for the resumption of the debate on the motion of Mr Anthony (Minister for Trade and Industry) described as Customs Tariff Proposals No. 15 (1972)— Debate resumed.

Question-put and passed.

19 ADJOURNMENT: Mr Chipp (Leader of the House) moved—That the House do now adjourn. Debate ensued.

Question-put and passed.
