- 19 ASIAN RESIDENTS OF CHRISTMAS ISLAND—MINISTERIAL STATEMENT: Mr Morrison (Minister for External Territories), by leave, made a ministerial statement relating to the progressive resettlement of Asian residents of Christmas Island.
  - Mr Peacock, by leave, also made a statement with reference to the matter.
- 20 Road safety—Ministerial statement: Mr Jones (Minister for Transport), by leave, made a ministerial statement relating to the Government's policy on road safety. Mr Fox and Mr Cohen, by leave, also made statements with reference to the matter.
- 21 ROAD SAFETY—SELECT COMMITTEE: Mr Jones (Minister for Transport) moved, pursuant to notice—
  - (1) That a Select Committee be appointed to inquire into and report on—
    - (a) the main causes of the present high level of the road toll in Australia;
    - (b) the most effective means of achieving greater road safety in Australia;
    - (c) the particular aspects of the problem to which those concerned with road safety could most advantageously direct their efforts, and
    - (d) the economic cost to the community of road accidents in Australia in terms of—
      - (i) material damage;
      - (ii) loss of man hours and earning capacity, and
      - (iii) cost of treatment of accident victims.
  - (2) That the committee recognise the responsibility of the States in these matters and seek their co-operation in all relevant aspects.
  - (3) That the committee consist of seven Members, four to be nominated by the Prime Minister, two to be nominated by the Leader of the Opposition and one to be nominated by the Leader of the Australian Country Party.
  - (4) That every nomination of a member of the committee be forthwith notified in writing to the Speaker.

- (5) That the Prime Minister nominate one of the government members of the committee as Chairman.
- (6) That the Chairman of the committee may, from time to time, appoint another member of the committee to be the Deputy Chairman of the committee, and that the member so appointed act as Chairman of the committee at any time when the Chairman is not present at a meeting of the committee.
- (7) That the committee have power to appoint sub-committees consisting of three of its members, and refer to any such sub-committee any matters which the committee is empowered to examine.
- (8) That three members of the committee constitute a quorum of the committee, and two members of a sub-committee constitute a quorum of that sub-committee.
- (9) That the committee or any sub-committee have power to send for persons, papers and records, to move from place to place, and to sit during any recess or adjournment.
- (10) That the committee have power to authorise publication of any evidence given before it and any document presented to it.
- (11) That the committee or any sub-committee have power to consider and make use of the minutes of evidence and records of the Select Committee on Road Safety appointed during the Twenty-seventh Parliament.
- (12) That recourse to technical and/or expert advice by the committee shall be subject to approval of the Speaker.
- (13) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
- (14) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.

Debate ensued.

Question—put and passed.

- 22 Environment and Conservation—Proposed Joint Committee: Dr Cass (Minister for the Environment and Conservation), having amended, by leave, notice No. 4, government business, moved—
  - (1) That a Joint Committee be appointed to inquire into and report on-
    - (a) environmental aspects of legislative and administrative measures which ought to be taken in order to ensure the wise and effective management of the Australian environment and of Australia's natural resources and
    - (b) such other matters relating to the environment and conservation and the management of Australia's natural resources as are referred to it by—
      - (i) the Minister for the Environment and Conservation, or
      - (ii) resolution of either House of the Parliament.
  - (2) That the committee recognise the responsibility of the States in these matters and seek their co-operation in all relevant aspects.
  - (3) That the committee consist of four members of the House of Representatives nominated by the Prime Minister, two members of the House of Representatives nominated by the Leader of the Opposition in the House of Representatives, one member of the House of Representatives nominated by the Leader of the Australian Country Party in the House of Representatives, two Senators nominated by the Leader of the Government in the Senate and two Senators nominated by the Leader of the Opposition in the Senate.
  - (4) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
  - (5) That the members of the committee hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
  - (6) That the Prime Minister nominate one of the government members of the committee as Chairman.

- (7) That the Chairman of the committee may, from time to time, appoint another member of the committee to be the Deputy Chairman of the committee, and that the member so appointed act as Chairman of the committee at any time when the Chairman is not present at a meeting of the committee.
- (8) That the committee have power to appoint sub-committees consisting of three or more of its members and to refer to any such sub-committee any of the matters which the committee is empowered to examine.
- (9) That the committee have power to send for persons, papers and records, to move from place to place and to sit during any recess or adjournment of the Parliament.
- (10) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
- (11) That the committee may proceed to the despatch of business notwithstanding that all members of the committee have not been appointed and notwithstanding any vacancy on the committee.
- (12) That five members of the committee constitute a quorum of the committee, and a majority of the members of a sub-committee constitute a quorum of that sub-committee.
- (13) That in matters of procedure the Chairman or Deputy Chairman presiding at the meeting have a deliberative vote and, in the event of an equality of voting, have a casting vote, and that, in other matters, the Chairman or Deputy Chairman have a deliberative vote only.
- (14) That the committee be provided with all necessary staff, facilities and resources.
- (15) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- .(16) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.

Debate ensued.

Question—put and passed.

23 Message from the Senate—Prices—Joint Committee: The following message from the Senate was reported:

The Senate having considered Message No. 22 of the House of Representatives has agreed to the following Resolutions in connection therewith, viz.:

- (1) That the Senate concurs in the Resolution transmitted to the Senate by Message No. 22 of the House of Representatives relating to the appointment of a Joint Committee to examine and report on Certain Matters Relating to Prices, subject to the following modifications—
  - (a) paragraph (1), sub-paragraph (a), after the words "private industry" add "and by the public sector",
  - (b) paragraph (1), sub-paragraph (b), after the words "private industry" add "and the public sector",
  - (c) paragraph (2), at end of paragraph add "and one Senator nominated by the Leader of the Australian Country Party in the Senate".
- (2) That the provisions of that Resolution, so far as they are inconsistent with the Standing Orders, have effect notwithstanding anything contained in the Standing Orders.

The Senate requests the concurrence of the House of Representatives in the Senate's modifications of the Resolution transmitted to the Senate by the House.

On the motion of Mr Barnard (Minister representing the Minister for Repatriation), the Bill was read a third time.

- 28 POSTPONEMENT OF ORDER OF THE DAY: Ordered—That order of the day No. 3, government business, be postponed until a later hour this day.
- 29 STATEMENT BY MINISTER: Mr Daly (Leader of the House), by leave, made a statement relating to Members' transport arrangements.
- 30 Housing Assistance Bill 1973: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Debate resumed.

Debate adjourned (Mr Bury), and the resumption of the debate made an order of the day for the next sitting.

31 ADJOURNMENT: Mr L. R. Johnson (Minister for Housing) moved—That the House do now adjourn. Question—put and passed.

And then the House, at nineteen minutes to ten o'clock p.m., adjourned until Tuesday, 1 May, at two o'clock p.m., unless Mr Speaker shall, by telegram addressed to each Member of the House, fix an earlier day of meeting.
