## TUESDAY, 1 MAY 1973

1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.

2 DEATH OF FORMER MEMBER (THE RIGHT HONOURABLE SIR ARTHUR FADDEN): Mr Whitlam (Prime Minister) referred to the death of the Right Honourable Sir Arthur Fadden, and moved—That this House expresses its deep regret at the death on 21 April 1973 of the Right Honourable Sir Arthur Fadden, G.C.M.G., a Member of this House for the Division of Darling Downs from 1936 to 1949 and for the Division of McPherson from 1949 to 1958, for many years Leader of the Australian Country Party, a Minister of the Crown, Prime Minister of Australia in 1941 and Leader of the Opposition between 1941 and 1943. It places on record its appreciation of his long and distinguished public service, and tenders its profound sympathy to his widow and family.

And Mr Snedden (Leader of the Opposition) having seconded the motion, and Mr Anthony (Leader of the Australian Country Party) and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

3 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:

Mr L. F. Bowen (Postmaster-General), Dr Klugman and Mr Thorburn—from certain citizens of Australia praying that the House will not extend the laws governing abortion and will uphold the right to life of the unborn child.

Dr Cairns (Minister for Overseas Trade)—from certain citizens of the Commonwealth praying that the Australian Government immediately establish diplomatic relations with the Provisional Revolutionary Government of the Republic of Vietnam and bring influence to bear in order to enable the implementation of the Agreement on Ending the War and Restoring Peace in Vietnam.

Mr Gorton—from certain citizens of the Commonwealth praying that this House will at once take steps to dedicate as a National Park an area of at least 1,436 square miles as recommended by the Northern Territory Reserves Board.

Mr Hewson—from certain citizens of Australia praying that no assistance, financial or otherwise, be provided by Australia to any country whatsoever which is itself subject to communist/socialist rule.

Mr Jarman—from certain citizens of the Commonwealth praying that the House should maintain the existing laws covering abortion.

Mr Lynch (Deputy Leader of the Opposition)—from certain electors of the Division of Flinders praying that the House will take immediate steps to seek an alternative site for the airport proposed in the area west of Yannathan.

- 4 SECURITY OF PARLIAMENT HOUSE—STATEMENT BY MR SPEAKER: Mr Speaker made a statement with reference to an explosion at the front of Parliament House which occurred in the early hours of Sunday, 22 April 1973, and to security measures taken in and around Parliament House.
- 5 QUESTIONS: Questions without notice were asked.

- 7 STATEMENT BY MEMBER—LEAVE TO MAKE NOT GRANTED: Mr Snedden (Leader of the Opposition) asked leave to make a statement.

  Objection being raised, leave not granted.
- 8 Suspension of standing orders moved: Mr Snedden (Leader of the Opposition) moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving that all documents relevant to the raid by Senator Murphy (Attorney-General) on the Australian Security Intelligence Organization and the execution of three Australian citizens by the Yugoslav Government, and the propriety of the Prime Minister's possession of the documents he has tabled, be debated.

Debate ensued.

The time allowed by standing order 91 for debate on the motion having expired—Question—put.

"That the Speaker of the House of Representatives and the President of the Senate in the Australian Parliament be requested to bring to the notice of their respective Houses the opinion of this Council that it is appropriate that legislation on matters of a non-federal nature in the Northern Territory be the exclusive prerogative of the Legislative Council to which body the Federal Parliament has properly delegated full powers in that respect.".
