 - Mr Lynch (Deputy Leader of the Opposition)—a similar petition from certain electors of the Division of Flinders.
 - Mr Beazley (Minister for Education) and Mr Lynch—from certain citizens of Australia praying that the House move to make available to the Tasmanian Government a special grant for the purpose of securing Lake Pedder in its natural state.
 - Mr Beazley—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.
 - Sir John Cramer—from certain citizens of Australia praying that the House acknowledge the right of every Australian child to equal grants of Government money spent on education and so instruct the proposed National Schools Commission.

11 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—POWER STRIKE IN NEW SOUTH WALES: Mr Speaker informed the House that Mr Fraser had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The serious situation caused by the New South Wales power strike".
