TUESDAY, 9 OCTOBER 1973

- 1 The House met, at eleven o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITORS: Mr Speaker informed the House that a delegation from the Parliament of the Federal Republic of Germany, led by Frau Liselotte Funcke, Vice-President of the Bundestag, was present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a warm welcome.
- 3 PETITIONS: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr D. M. Cameron, Mr Drury, Mr Jarman, Mr McLeay and Mr Wilson—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr Luchetti and Mr Lucock—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.
 - Mr Edwards—from certain citizens of Australia praying that the House take steps to ensure that the Government does not site a second international airport for Sydney in the Galston area or surrounding suburbs.
 - Mr Enderby (Minister for Secondary Industry)—from certain citizens of Australia praying that the House urge the Government to ensure that, where necessary, kangaroos be killed or trapped by qualified and licensed governmental officers and that poisoning of all native fauna be prohibited.
 - Mr Whan—from certain service station proprietors of Queanbeyan, New South Wales, praying that the Government take urgent steps to enable Queanbeyan and Canberra petrol retailers to compete on equal terms.
 - Mr Wilson—from certain citizens of Australia praying that the House acknowledge the right of every Australian child to equal grants of Government money spent on education.

- Senator Willesee (Special Minister of State) would, in the near future, be appointed also Minister for Foreign Affairs.
- Mr Whitlam also informed the House that Mr Bryant would represent the Minister for Aboriginal Affairs in this House, and that during the absence, owing to illness, of Senator Bishop (Minister for Repatriation), Mr Bryant was acting as Minister for Repatriation.

Condemns the Opposition for its blatant attempt to involve the Government in a major industrial dispute to which the New South Wales Liberal Coalition Government is a party, and in which employees of the New South Wales Electricity Commission at the Tumut Power Stations covered by New South Wales Industrial Awards and under that Commission's industrial discipline are involved, and

Further condemns the Opposition for seeking to impose upon the Government, in respect of State employees a course of industrial action which that Government is not prepared to take in any power station in New South Wales, knowing that it would result in a complete cessation of power generation".
