Robinson and Mr Wilson—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
  - Mr MacKellar, Mr McMahon and Mr Turner—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.
  - Mr Kerin—from certain citizens of Australia praying that the House immediately revoke all Australian whaling licences and ban the importation of all whale produce.

7 Constitution Alteration (Mode of Altering the Constitution) Bill 1974 [1973]: Mr Whitlam (Prime Minister), pursuant to notice, presented a Bill for an Act to facilitate alterations to the Constitution and to allow Electors in Territories, as well as Electors in the States, to vote at Referendums on Proposed Laws to alter the Constitution.

Bill read a first time.

Mr Whitlam moved—That the Bill be now read a second time.

Debate adjourned (Mr Bonnett), and the resumption of the debate made an order of the day for the next sitting.
