Proposed expenditure—Department of Urban and Regional Development, \$10,800,000—debated and agreed to.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr Scholes reported accordingly.

Ordered—That the House will, at the next sitting, again resolve itself into the said committee.

17 ADJOURNMENT: Mr Daly (Leader of the House) moved—That the House do now adjourn. Debate ensued.

The House continuing to sit until eleven o'clock p.m.—Mr Speaker adjourned the House until tomorrow at half-past eleven o'clock a.m.
