- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Corbett, Mr Drury, Mr McLeay and Mr Wilson—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr Anthony (Leader of the Australian Country Party)—from certain citizens of Australia praying that the Government will not allow dismemberment of the Repatriation Department or the transfer of any of its functions to other authorities or departments.
 - Mr Bury—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.
 - Mr McLeay—from certain citizens of Australia praying that the Government legislate to protect the whale from commercial exploitation.
 - Mr Ruddock—from certain citizens of Australia praying that the House take steps to ensure that the Government does not site a second international airport for Sydney in the Galston area or surrounding suburbs.

13 CONCILIATION AND ARBITRATION BILL 1974: Mr C. R. Cameron (Minister for Labour), pursuant to notice, presented a Bill for an Act to amend the Law relating to Conciliation and Arbitration in relation to the Certification of Agreements and the Operation and Cancellation of Certified Agreements.

Bill read a first time.

Mr Cameron moved—That the Bill be now read a second time.

Debate adjourned (Mr Fraser), and the resumption of the debate made an order of the day for the next sitting.

14 PUBLIC WORKS COMMITTEE—PROPOSED REFERENCE OF WORK—POST OFFICE ADMINIS-TRATIVE BUILDING, PERTH: Mr L. R. Johnson (Minister for Housing and Construction) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969–1973, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report: Construction of proposed post office administrative building, Perth.

Mr Johnson presented plans in connection with the proposed work.

Debate ensued.

Mr Berinson was granted leave to continue his speech when the debate is resumed.

- 15 SENATE ELECTION AND REFERENDUM PROPOSALS—MINISTERIAL STATEMENT: Mr Whitlam (Prime Minister), by leave, made a ministerial statement informing the House that the Government had decided to invite His Excellency the Governor-General to communicate with the State Governors proposing that the next Senate election be held on Saturday, 18 May 1974. When replies were received from the States he would inform the House of the full timetable proposed for the election. Mr Whitlam also informed the House of his action on certain referendum proposals and that His Excellency would submit to the electors the following proposed laws: Constitution Alteration (Simultaneous Elections) 1974, Constitution Alteration (Mode of Altering the Constitution) 1974, Constitution Alteration (Democratic Elections) 1974 and Constitution Alteration (Local Government Bodies) 1974. Mr Whitlam stated that it was intended that the referendums would be held concurrently with the Senate election.
 - Mr Snedden (Leader of the Opposition), by leave, making a statement with reference to the referendum proposals—
 - *Point of order:* Mr Daly (Leader of the House) raised a point of order that Mr Snedden should not revive a previous debate and should confine his remarks to the matters referred to by the Prime Minister.

Deputy Speaker's ruling: The Deputy Speaker (Mr Luchetti) ruled that Mr Snedden should relate his remarks to the date of the referendums and the Senate election.

Dissent from ruling moved: Mr Snedden moved—That the ruling be dissented from. Debate ensued.

Mr Sinclair (Deputy Leader of the Australian Country Party) moved—That Mr Anthony (Leader of the Australian Country Party) be granted an extension of time.
