# TUESDAY, 30 JULY 1974

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 Message from the Governor-General—Joint sitting: The following message from His Excellency the Governor-General was read by Mr Speaker:

#### **MESSAGE**

His Excellency the Honourable Sir John Robert Kerr, the Governor-General of Australia

To-

The Honourable James Francis Cope, Speaker of the House of Representatives.

I have, by my Proclamation a copy of which is attached, convened a joint sitting of the members of the Senate and of the House of Representatives for the purposes, and to commence at the time and in the place, specified in the said Proclamation: And I desire you forthwith to inform all Honourable Members accordingly.

# **PROCLAMATION**

Australia
JOHN R. KERR
Governor-General

By His Excellency the Governor-General of Australia

WHEREAS a Proclamation made on 11 April 1974 by the Governor-General of Australia then holding office recited that the conditions upon which the Governor-General is empowered by section 57 of the Constitution to dissolve the Senate and the House of Representatives simultaneously had been fulfilled in respect of the several proposed laws intituled:

Commonwealth Electoral Act (No. 2) 1973
Senate (Representation of Territories) Act 1973
Representation Act 1973
Health Insurance Commission Act 1973
Health Insurance Act 1973
Petroleum and Minerals Authority Act 1973:

AND WHEREAS, by the said Proclamation, the said Governor-General dissolved the Senate and the House of Representatives accordingly:

AND WHEREAS, since that dissolution and the election of the Twenty-ninth Parliament, the conditions upon which the Governor-General is empowered by section 57 of the Constitution to convene a joint sitting of the members of the Senate and of the House of Representatives have been fulfilled in respect of each of the said proposed laws:

Now THEREFORE I, Sir John Robert Kerr, the Governor-General of Australia, do by this my Proclamation convene a joint sitting of the members of the Senate and of the House of Representatives, to commence in the House of Representatives Chamber at Parliament House, Canberra at 10.30 o'clock in the morning on 6 August 1974, at which they may deliberate and shall vote together upon each of the said proposed laws as last proposed by the House of Representatives:

AND all members of the Senate and of the House of Representatives are required to give their attendance accordingly.

3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Beazley (Minister for Education) and Mr Garland—from certain citizens of Australia praying that the Government ensure that the publication and availability of pornographic literature and films are restricted and that people are made aware of the dangers to the community of such material.

Mr Bennett and Mr Garland—from certain citizens of Australia praying that Parliament (1) take any steps necessary either to direct the Commonwealth Banking Corporation to preserve and restore the Palace Hotel, St George's Terrace, Perth, or itself to acquire, preserve and restore the hotel on its present site and (2) make available any funds necessary to purchase the entire contents of the hotel from the owners.

Mr Drury and Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.

Mr Calder and Dr Jenkins—from certain citizens of Australia praying that the Government (1) grant a cash loading to pensioners, (2) increase within a reasonable period the weekly pension to 25 per cent of average weekly earnings, (3) freeze the tapered means test ceilings of income and assets and (4) give an assurance that the proposed national superannuation Bill will provide pensioners with a guaranteed minimum income of 30 per cent of quarterly adjusted average weekly earnings.

Mr Bryant (Minister for the Capital Territory)—from certain citizens of Australia praying that the House urge the Prime Minister to make known publicly to the Indonesian authorities when he visits Indonesia the concern of Australians about the plight of Indonesian political prisoners.

Mr Hurford—from certain citizens of Australia praying that the Government take immediate steps to implement a pension scheme for males bringing up and supporting their children and to make tax deductible the total wage of a house-keeper employed by any parent working full time.

Mr Jarman—from certain citizens of Australia praying that the Government immediately increase, as an interim measure, current grants made to children in non-government schools to at least 50 per cent of the cost of educating children in government schools.

Mr Jarman—from certain electors of Victoria praying that War Service Homes rights be granted immediately to all wartime ex-servicewomen.

Mr McLeay—from certain citizens of Australia praying that the Government set aside sufficient funds for research into the production of industrial solar energy.

Mr McLeay—from certain citizens of Australia praying that the Government legislate to protect the whale from commercial exploitation.

16 PRICES JUSTIFICATION BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Debate resumed.

"'(3) When the company receives a copy of the report by the Tribunal in relation to the price at which the company supplies or proposes to supply goods or services of a particular description in a particular locality—

(a) the company shall, within 14 days after the report is so received, give notice in writing to the Tribunal specifying the price at which the company is supplying or proposes to supply goods or services of that description in that locality; and (b) the Tribunal shall make particulars of the price available to the public within 14 days after it receives the notice under paragraph (a).

"'(4) A company that contravenes paragraph (3) (a) is guilty of an offence and is punishable, on conviction, by a fine not exceeding \$1,000.'."

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill to be reported with amendments.
