THURSDAY, 3 OCTOBER 1974

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Dawkins and Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr Nicholls and Mr Wilson—from certain citizens of Australia praying that the House take action against the Government's decision to recognise the sovereignty of the Soviet Union over the Baltic States of Estonia, Latvia and Lithuania.
 - Mr Enderby (Minister for Manufacturing Industry)—from certain residents of the Australian Capital Territory praying that the House urge the Government not to proceed with the introduction of self-government for the Australian Capital Territory until the residents of the Territory are consulted, by means of a referendum, on the issue.
 - Mr Bennett—from certain citizens of Australia praying that Parliament (1) take any steps necessary either to direct the Commonwealth Banking Corporation to preserve and restore the Palace Hotel, St George's Terrace, Perth, or itself to acquire, preserve and restore the hotel on its present site and (2) make available any funds necessary to purchase the entire contents of the hotel from the owners.
 - Mr King—from certain citizens of Australia praying that the House ask the Australian Commission on Advanced Education to consider in its 1976-78 Triennium Report an allocation of funds for the provision of Union Facilities at the Royal Melbourne Institute of Technology.
 - Mr Morris—from certain citizens of Australia praying that the Government hasten to introduce a universal health scheme so that health care services in Australia can function efficiently and economically.
 - Mr Wilson—from certain citizens of Australia praying that the law be amended to allow taxpayers to deduct from income, for income tax purposes, all rates and taxes paid by them in respect of their primary home or land bought for the purpose of building thereon.

- 7 NATIONAL COMPENSATION BILL 1974: Mr Bowen (Minister representing the Minister for Repatriation and Compensation), pursuant to notice, presented a Bill for an Act to make Provision for the Payment of Benefits in respect of Incapacity as the Result of Sickness (including Personal Injury), for the Payment of Widows' Pensions and certain other Benefits, and for purposes connected therewith.

Debate adjourned (Dr Forbes), and the resumption of the debate made an order of the day for the next sitting.

8 BROADCASTING AND TELEVISION BILL (No. 2) 1974: Dr Cass (Minister representing the Minister for the Media), pursuant to notice, presented a Bill for an Act to amend the *Broadcasting and Television Act* 1942–1973, as amended by the *Broadcasting and Television Act* 1974.

Dr Cass moved-That the Bill be now read a second time.

Question—put and passed—Bill read a second time.

On the motion of Mr Bowen (Special Minister of State), the following amendment was made: Clause 9, page 6, line 35, after "corporation" insert "or an office or appointment as a member of a body established to manage, conduct or control the business or affairs of, or otherwise to perform functions in relation to, such a corporation".

Bill, as amended, agreed to.

- 17 APPROPRIATION BILL (No. 1) 1974-75-BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Snedden (Leader of the Opposition), viz.—That all words after "That" be omitted with a view to substituting the following words: "this House is of the opinion that the Budget fails to tackle Australia's economic crisis, in that:
 - (1) unemployment is permitted to grow and the prospect for school leavers is prejudiced,
 - (2) inflation is accelerated,
 - (3) existing poverty is ignored and new poverty is created,
 - (4) personal income tax is increased 45 per cent,
 - (5) living standards will be lowered,
 - (6) private enterprise is stifled,
 - (7) Government power is further centralised,
 - (8) individual incentive and thrift is penalised, and
 - (9) a double tax is levied on estates;
 - and because the Government:
 - (a) has made the Budget a socialist vehicle to intensify the attack on the States and break down the free enterprise system,
 - (b) believes the absurdity that the Government can spend without people paying or can build without people producing, and
 - (c) has preached private restraint but has threatened its achievement by its own Government extravagance"---

Debate resumed.
