- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

 - Mr Lynch (Deputy Leader of the Opposition), Mr Bonnett, Mr Fisher, Mr Fraser, Mr Fry, Mr Gorton, Dr Jenkins, Mr King, Mr Lusher and Mr Mathews—from certain citizens of Australia praying that the House oppose the Family Law Bill.
 - Dr Cass (Minister for the Environment and Conservation), Mr King, Mr Morris and Mr Street—from certain citizens of Australia praying that the House pass the Family Law Bill.
 - Mr Barnard (Minister for Defence)—from certain citizens of Australia praying that the House take urgent steps to ensure that further mining and export from Australia of uranium, except for bio-medical purposes, be banned and that the Australian Atomic Energy Commission be transformed into an Australian Energy Commission.
 - Mr Mulder—from certain citizens of Australia praying that the Government give urgent consideration to proposals for the organising of fields of labour to alleviate unemployment.
 - Mr Staley—from certain citizens of Australia praying that the Government increase child endowment.
 - Mr Wentworth—from certain citizens of Australia praying that Members in Parliament call for and hold a general election forthwith.

- 5 GRIEVANCE DEBATE: Pursuant to the provisions of standing order 106, the order of the day having been read—
 - Question proposed—That grievances be noted. Debate ensued.

Mr Wentworth moved, as an amendment—That the following words be added to the motion: "and in particular the House notes with distaste the evasive and contemptuous attitude of the Prime Minister within it, and his custom of making deliberately misleading statements with the objective of deceiving both it and the electorate".

Debate adjourned (Mr Killen), and the resumption of the debate made an order of the day for the next sitting.

8 AUSTRALIAN FILM COMMISSION BILL 1975: Mr Morrison (Minister representing the Minister for the Media) presented a Bill for an Act to establish an Australian Film Commission.

Bill read a first time.

Mr Morrison moved—That the Bill be now read a second time.

Debate adjourned (Mr Peacock), and the resumption of the debate made an order of the day for the next sitting.

And so it was resolved in the affirmative-Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

On the motion of Mr Daly (Minister for Services and Property), the following amendment was made, after debate: (Clause 3, page 11, lines 13-31, omit sub-section (1) of proposed section 153G, substitute the following sub-sections:

"(1) In this section, a reference to a gift, in relation to a return, does not include a reference to a gift the value of which is less than \$100 unless the value of the gift, together with the value of any other gift or gifts made by or on behalf of the same donor during the period to which the return relates, exceeds an aggregate value of \$100.

"(1A) Within 12 weeks after the day fixed for the polling for an election, every person who was at any time the official agent of a candidate for the election shall file with the Chief Australian Electoral Officer a return in the form prescribed, setting out—

(a) particulars of-

- (i) all gifts authorized by him as provided by section 151; and
- (ii) all gifts received by him on behalf of, by arrangement with, or with the concurrence of, the candidate,

during that time and the names and addresses of the persons by whom the gifts were made and the amount or value of each gift; and

(b) particulars of all electoral expenditure authorized by him as provided by section 146 during that time, the names and addresses of the persons by whom the expenditure was incurred and the amount of the expenditure incurred by each of them.".

Bill, as amended, agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Scholes reported accordingly.

On the motion of Mr Daly, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

- 13 FAMILY LAW BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Stewart (Minister for Tourism and Recreation), viz.— That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that the Bill should give expression to the following principles—
 - (a) that the family is the basic and stable unit of the Australian society;
 - (b) that marriage should be buttressed;
 - (c) that marriage should be permanent and secure;
 - (d) that full and proper recognition be given to the status and rights of a woman as wife and mother;
 - (e) that there should be full and proper protection of the wife and children in the event of the dissolution of a marriage;
 - (f) that there is need for children to be reared and cared for by a present parent, and
 - (g) that marriage should be dissolved only when a Court is satisfied on objective grounds that the marriage has irretrievably broken down or that the parties have lived separately and apart for not less than two years"—

Debate resumed.

Debate adjourned (Mr Corbett), and the resumption of the debate made an order of the day for the next sitting.

- 14 ROAD SAFETY—STATEMENT BY MEMBER: Mr Cohen, by leave, made a statement relating to recommendations of the Standing Committee on Road Safety concerning the adoption of lower absolute speed limits for all States in Australia.
- 15 CORPORATIONS AND SECURITIES INDUSTRY BILL 1975: Mr Enderby (Attorney-General), pursuant to notice, presented a Bill for an Act relating to Corporations and the Securities Industry.

Bill read a first time.

Mr Enderby moved-That the Bill be now read a second time.

Debate adjourned (Mr Ellicott), and the resumption of the debate made an order of the day for the next sitting.

- 16 ADJOURNMENT: Mr Daly (Leader of the House) moved—That the House do now adjourn. Debate ensued.
- The House continuing to sit until eleven o'clock p.m.—Mr Deputy Speaker adjourned the House until Tuesday next at fifteen minutes past two o'clock p.m.
