No. 71 THURSDAY, 15 MAY 1975

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITOR: Mr Speaker informed the House that the Honourable G. A. Regan, Q.C., M.L.A., Premier of Nova Scotia and Chairman of the Executive Committee of the General Council of the Commonwealth Parliamentary Association, was present in the gallery. On behalf of the House, Mr Speaker extended to the visitor a very warm welcome.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Barnard (Minister for Defence), Mr Lynch (Deputy Leader of the Opposition), Mr Bonnett, Mr Bourchier, Mrs Child, Mr Erwin, Mr Gorton, Mr Hodges, Mr Lamb, Mr Macphee, Mr Oldmeadow, Mr Staley and Mr Street—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
 - Mr Ellicott, Mr Erwin, Mr Macphee, Mr Oldmeadow and Mr E. L. Robinson—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
 - Mr Anthony (Leader of the National Country Party of Australia), Mr Connolly and Mr Gorton—from certain employees and agents of the Australian insurance industry, in terms similar to the last preceding petition.

12 SUPERANNUATION ACT AMENDMENT BILL 1975: Dr J. F. Cairns (Treasurer), pursuant to notice, presented a Bill for an Act to amend the Superannuation Act 1922–1974. Bill read a first time.

Dr Cairns moved-That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

13 DEFENCE FORCE RETIREMENT AND DEATH BENEFITS BILL 1975: Dr J. F. Cairns (Treasurer), pursuant to notice, presented a Bill for an Act to amend the *Defence Force Retirement* and Death Benefits Act 1973-1974.

Bill read a first time.

Dr Cairns moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

14 DEFENCE FORCE OMBUDSMAN BILL 1975: Mr Barnard (Minister for Defence), pursuant to notice, presented a Bill for an Act to Provide for the Appointment of a Defence Force Ombudsman, and to Define his Functions and Powers.

Bill read a first time.

Mr Barnard moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

17 Public Service Bill 1975: Mr Bowen (Minister assisting the Prime Minister in matters relating to the Public Service), pursuant to notice, presented a Bill for an Act to amend the *Public Service Act* 1922–1974.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

18 HOUSING LOANS INSURANCE BILL 1975: Mr Bowen (Special Minister of State), pursuant to notice, presented a Bill for an Act relating to the Housing Loans Insurance Corporation.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

- 19 POSTPONEMENT OF NOTICES: Ordered—That notices Nos. 8 and 9, government business, be postponed until a later hour this day.
- 20 Family Law Bill 1974—Procedural resolution: Mr Daly (Leader of the House) moved, pursuant to notice—

(1) That, unless otherwise ordered—

- (a) during the consideration of the Family Law Bill 1974 in committee of the whole House—
 - (i) the operation of standing order 91 be varied to provide that each Member, including the Minister in charge of the Bill, may speak once only to each clause for a period not exceeding 5 minutes without extension of time:
 - (ii) clauses 1 to 47 be postponed until after clause 48 on which clause a cognate debate shall take place on both the clause and all proposed amendments to the clause circulated by Members; and
 - (iii) the time allowed for the cognate debate on clause 48 shall not exceed 5 hours. At the conclusion of that time, or such earlier time as the debate may conclude, the Chair shall put, without further debate, questions on any proposed amendments to the clause which have been circulated by any Members and which are capable of being put and any other questions necessary to conclude consideration of the clause; and

- (b) until the Family Law Bill 1974 is disposed of-
 - (i) the operation of standing order 107 shall be suspended; and
 - (ii) government business shall take precedence over general business on each sitting day.
- (2) That the foregoing provisions of this resolution have effect notwithstanding anything contained in the standing orders.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Adjournment negatived: It being half-past ten o'clock p.m.—The question was proposed—That the House do now adjourn.

Mr Crean (Minister for Overseas Trade) requiring the question to be put forthwith without debate—

Mr Bowen continued his speech.

Debate adjourned (Mr I. L. Robinson), and the resumption of the debate made an order of the day for the next sitting.
