WEDNESDAY, 9 JULY 1975

- 1 The House met, at half-past two o'clock p.m., according to the terms of the resolution of 5 June last. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 RETURN TO WRIT—BASS DIVISION: Mr Speaker announced that he had received a return to the writ which he had issued on 4 June for the election of a Member to serve for the Electoral Division of Bass, in the State of Tasmania, to fill the vacancy caused by the resignation of the Honourable Lance Herbert Barnard, and that, by the endorsement on the writ, it was certified that Kevin Eugene Newman had been elected.
- 3 Member sworn: Kevin Eugene Newman was introduced, and made and subscribed the oath required by law.
- 4 DEATH OF SENATOR B. R. MILLINER: Mr Whitlam (Prime Minister) referred to the death of Senator B. R. Milliner, and moved—That this House expresses its profound regret at the death on 30 June 1975 of Bertie Richard Milliner, a Senator for the State of Queensland since 1968, places on record its appreciation of his meritorious public service and extends its deepest sympathy to his widow and family.
 - And Mr Fraser (Leader of the Opposition) having seconded the motion, and Mr Anthony (Leader of the National Country Party of Australia) and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

- 5 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Stewart (Minister for Tourism and Recreation), Mr Fraser (Leader of the Opposition), Mr Lynch (Deputy Leader of the Opposition), Mr Corbett, Mr Hewson, Mr Hodges, Mr Kerin, Mr Killen, Mr MacKellar, Mr Millar, Mr Reynolds, Mr Snedden and Mr Sullivan—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
 - Mr Fraser, Mr Anthony (Leader of the National Country Party of Australia), Mr Jacobi, Mr Macphee and Mr Wilson—from certain employees and agents of the Australian insurance industry praying that the House reject the Australian Government Insurance Office Bill.
 - Mr Fraser, Mr Howard, Mr Hewson, Mr MacKellar and Mr Sullivan—from certain citizens of Australia in terms similar to the last preceding petition.
 - Dr J. F. Cairns, Mr Graham and Mr MacKellar—from certain citizens of Australia praying that the Government (1) cease the mining and export of uranium until safe disposal methods have been guaranteed, (2) increase expenditure on research into clean and inexhaustible sources of energy and (3) aid underdeveloped countries in their plea for a share of world energy resources.

- Mr Lusher—from certain citizens and foreign students in Australia praying that the House ensure the political and other rights of foreign students who study in Australia.
- Mr Ruddock—from certain citizens and foreign students in Australia praying that the House agree to the changes proposed by the Australian Union of Students to the tertiary education scheme.
- Mr Snedden—from certain citizens of Australia praying that the Government increase child endowment in the next Budget.

 - Senator J. R. McClelland had been appointed Minister for Labor and Immigration and Minister assisting the Prime Minister in matters relating to the Public Service.

7 MATTER OF SPECIAL INTEREST—OVERSEAS LOAN NEGOTIATIONS: Mr Whitlam (Prime Minister) indicated to the House that it was proposed to discuss a matter of special interest relating to overseas loan negotiations on which it was not desired to formulate a motion in express terms.

Mr Whitlam then moved—That the time allotted to the debate on overseas loan negotiations be until 10 p.m. this day.
