## THURSDAY, 4 SEPTEMBER 1975

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Dr Cass (Minister for the Media), Mr Fraser (Leader of the Opposition), Mr Sinclair (Deputy Leader of the National Country Party of Australia), Mr Bourchier, Mr Bungey, Mr Drummond, Mr Garland, Mr Nixon, Mr Staley and Mr Wilson—from certain citizens of Australia praying that the House either decrease or reject proposed increases in postal and telephone charges.
  - Mr Bungey, Mr Connolly, Mr Hyde, Mr Kelly, Mr McLeay and Mr Macphee—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
  - Mr Macphee—from certain employees and agents of the Australian insurance industry in terms similar to the last preceding petition.
  - Mr Holten and Mr McKenzie—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
  - Mr Beazley (Minister for Education)—from certain citizens and foreign students in Australia praying that the House agree to the changes proposed by the Australian Union of Students to the tertiary education scheme.
  - Mr Fisher—from certain citizens of Australia praying that the House request the Australian Postal Commission not to downgrade the Nullawil Post Office, Victoria
  - Mr Holten—from certain Australian Government employees praying that the House pass the Superannuation Bill 1975 without amendment or delay.
  - Mr Holten—from certain citizens of Australia praying that the House (1) engender greater respect for the nuclear family and frustrate its fragmentation as the basic unit of society and (2) ensure that Australian youth is led to loyalty to the Crown, service to others, and righteousness and integrity of character.
  - Mr James—from certain citizens of Australia praying that the Scouting movement be granted relief through sales tax exemption.
  - Mr Katter—from certain electors of the Division of Kennedy praying that the House take action which will require the Australian Broadcasting Control Board to provide the Electoral Division of Kennedy with a television service where it is not now provided.
  - Mr McKenzie—from certain citizens of Australia praying that the House ensure that the Government (1) prohibit the export of mineral sands from Fraser Island and (2) assist the Queensland Government and other bodies to conserve the natural environment of Fraser Island for the benefit of the people of Australia.
  - Mr Nixon—from certain citizens of Australia praying that the House grant \$200,000 to the Shire of South Gippsland, Victoria, for maintenance of services at the 1972 level and that it increase this grant annually in line with the inflation rate. Petitions received.
