# WEDNESDAY, 1 OCTOBER 1975

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Bonnett, Mr Lucock and Mr Millar—from certain citizens of Australia praying that the cadet corps be continued.
  - Mr Drury and Mr Howard—from certain citizens of Australia praying that the House either decrease or reject proposed increases in postal and telephone charges.
  - Mr Drury and Mr King—from certain citizens of Australia praying that postal rate increases be decreased or rejected and special rates be provided for Category A magazines.
  - Mr Reynolds and Mr Sullivan—from certain citizens of Australia praying that (1) pensions be related to average weekly earnings and (2) no charge be made for the installation or rental of telephones for pensioners.
  - Mr Berinson (Minister for Environment)—from certain citizens of Australia praying that the Government reduce the cost of the subscription to *Hansard*.
  - Mr Fraser (Leader of the Opposition)—from certain citizens of Australia praying that the Government take no measures to interfere with existing television program standards or to permit easier entry into Australia, or production in Australia, of pornographic material.
  - Mr Connolly—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
  - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
  - Mr Kelly—from certain citizens of Australia praying that the subsidy on postal charges to the religious, charitable and trade union press be increased.
  - Mr McLeay—from certain citizens of Australia praying that no further measures be taken which will make home ownership unattractive to those who have a home and unachievable for those who have not.
  - Mr Sherry—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
  - Mr Viner—from certain citizens of Australia praying that the community's medical research needs be reassessed and funds sought by the National Health and Medical Research Council be allocated to it.
  - Mr Wilson—from certain citizens of Australia praying that the Government (1) suspend sales of uranium to any country engaged in violent conflict, (2) suspend the mining of uranium except that used for medical purposes and (3) encourage research into safer sources of energy.
