HOUSE OF REPRESENTATIVES.

TUESDAY, 23RD JULY, 1907.

1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

- 2. MEMBER SWORN.—The Honorable William Morris Hughes made and subscribed the oath required by law.
- 3. PETITIONS.—-Petitions in reference to the proposed Conditions of Tender for Mail Service, asking that vessels under the proposed contract shall call at the principal port of each State, that Brisbane be a port of call, that provision be made for cold storage, that Queensland be not called on to pay more than her proper proportion of the mail subsidy, and praying that the House will frame such measures as will safeguard the equal rights of each State, were presented as under :--

Petitions severally received.

4. PRINTING COMMITTEE—SECOND REPORT FROM.—Mr. Hutchison, Acting Chairman, brought up the Second Report from the Printing Committee (sitting in conference with the Printing Committee of the Senate).

Property for Public Purposes Acquisition Act-Land acquired under, at Singleton, New South Wales-As a site for a Rifle Range.

- 6. FEDERATION-CONFERENCE (1899) OF PREMIERS re.-Mr. Johnson moved, pursuant to notice, That the Memorandum of the Conference of Premiers, dated Melbourne, 3rd February, 1899, bearing the signatures of the Premiers of the six federating States, and dealing with the following: matters, viz. :-
 - (1) Representation in the Senate;

 - (2) The "Braddon" Clause;
 (3) The Capital of the Commonwealth;
 - (4) The Boundaries of the States ;
 - (5) Inland Rivers, Money Bills, and Judicial Appeal from States;
 - (6) Alteration of Constitution;
 - (7) The Senate ;

be printed for information and reference as a Parliamentary Paper.

Question-put and resolved in the affirmative.

- 8. POSTAL RATES BILL (1907).-Mr. Chapman moved, pursuant to notice, That he have leave to bring in a Bill for an Act relating to Postal Rates.
 - Debate ensued.

Question-put and resolved in the affirmative.

Mr. Chapman then brought up a Bill intituled "A Bill for an Act relating to Postal Rates," and moved, That it be now read a first time.

Question—put and resolved in the affirmative.—Bill read a first time. Ordered—That the second reading be made an Order of the Day for to-morrow.

- 9. BOUNTIES BILL (1907).-The Order of the Day having been read for the second reading of this Bill-Mr. Groom moved, That the Bill be now read a second time. Debate ensued.
 - Mr. Sampson moved, That the debate be now adjourned.
 - Question—That the debate be now adjourned—put and resolved in the affirmative.

Ordered —That the resumption of the debate be made an Order of the Day for to-morrow.

10. ADJOURNMENT.-Sir William Lyne moved, That the House do now adjourn. Debate ensued. Question-put and resolved in the affirmative.

And then the House, at twenty-eight minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
