- 3. Supply Bill (No. 2) 1907-8.—The Order of the Day having been read for the consideration of the Report from the Committee of the whole House on this Bill—Sir William Lyne moved, That the Report be now adopted.

- 5. Message from His Excellency the Governor-General.—Parliamentary Allowances Bill (1907).—
 The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:—

Message No. 9.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act relating to the Allowance to Members of each House of the Parliament of the Commonwealth.

Ordered-That the foregoing Message be considered in Committee of the whole House forthwith.
