- 1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. Petitions.—Mr. Joseph Cook presented a Petition from D. Izett, honorary organizing secretary of the Child Study Association of Australasia, in regard to the taxation of food and clothing necessary to the life and well-being of the motherhood and childhood of Australia, and the taxation, direct or indirect, of any materials that would cause an increase in rents, and praying that all Customs duties may be removed from food and clothing, &c. (as set forth in the Petition), necessary to the health, comfort, and decency of the people.
 - Sir William Lyne presented a Petition from certain electors of Hume, New South Wales, and elsewhere, praying that the House will reject, or at least greatly modify, the proposed Customs duties on articles of almost daily need for the necessaries of life and for the agricultural and industrial prosperity of the State, particularly on wearing apparel, agricultural and other machinery, and wire netting.

Petitions severally received and read.

3. GOVERNMENT BUSINESS—PRECEDENCE TO.—Sir William Lyne moved, pursuant to notice, That on each sitting day, until otherwise ordered, Government business shall take precedence of General business.
