FRIDAY, 29TH NOVEMBER, 1907.

- 1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.
- 2. PETITIONS.—Mr. Dugald Thomson presented a Petition from the Council of the Sydney Chamber of Commerce, under the common seal of the said Chamber, praying that the House will see fit to lay aside the Australian Industries Preservation Bill (1907).
 - Mr. Maloney presented a Petition from members of the musical trade of Victoria praying that Parliament will not sanction any duty on pianos higher than that levied under the first Federal Tariff.

Petitions severally received and read.

3. WAYS AND MEANS.—The House, according to Order, resolved itself into the Committee of Ways and Means.

Mr. Speaker resumed the Chair; Mr. McDonald reported that the Committee had made progress, and that he was directed to ask, That the Committee may have leave to sit again. Resolved—That the House will, on Monday next, again resolve itself into the said Committee.
