1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

2. MESSAGE FROM HIS EXCELLENCY THE GOVERNOR-GENERAL .-- ASSENT TO BILL .-- The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :-

Message No. 23.

A Bill intituled "An Act relating to Procedure on Applications for a Declaration under the 'Excise Tariff 1906' (Act No. 16 of 1906)," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

- 3. MINISTERIAL APPOINTMENT.-Mr. Deakin informed the House that the honorable Member for Bourke, Mr. Hume Cook, had been chosen a Member of the Executive Council and a Member of the Cabinet.
- 4. THE LATE MOST HONORABLE THE MARQUIS OF LINLITHCOW, FIRST GOVERNOR-GENERAL OF AUSTRALIA. -VOTE OF CONDOLENCE.- Mr. Deakin moved, by leave, That this House desires to express its deepest sympathy with Lady Linlithgow and family in the great loss sustained by them by the death of the late Marquis, and to place on record its regret and grief at the untimely decease of the first Governor General of Australia, whose abilities and kindness had endeared him to its people.
  - Mr. Reid and Mr. Fisher having addressed the House in support of the motion, and all Members present having risen in silence-

  - Question-put and resolved in the affirmative. Resolved---That Mr. Speaker be requested to convey the foregoing resolution, through His Excellency the Governor-General, to the Marchioness of Linlithgow.

7. SUSPENSION OF STANDING ORDERS .- Sir William Lyne moved, by leave, That the Standing Orders be suspended in order to enable all steps to be taken to obtain Supply, and to pass a Supply Bill through all its stages without delay. Debate ensued.

Question---put and resolved in the affirmative.

8. SUPPLY RESOLUTION.-The resolution reported from the Committee of Supply was read, and is as follows :-

Resolved-That a sum not exceeding Seven hundred and sixty thousand four hundred and ninety-nine pounds be granted to His Majesty for or towards defraying the services of the year ending 30th June, 1908.

And the said resolution was adopted by the House.

9. WAYS AND MEANS .- The House, according to Order, resolved itself into the Committee of Ways and Means.

Mr. Speaker resumed the Chair; Mr. McDonald reported that the Committee had agreed to a certain resolution.

Mr. McDonald also acquainted the House that he was directed to ask, That the Committee may have leave to sit again.

Resolved - That the House will, this day, again resolve itself into the said Committee.

10. WAYS AND MEANS RESOLUTION .- The resolution reported from the Committee of Ways and Means was read, and is as follows :---

Resolved-That towards making good the Supply granted to His Majesty for the services of the year ending 30th June, 1908, a sum not exceeding Seven hundred and sixty thousand four hundred and ninety-nine pounds be granted out of the Consolidated Revenue Fund.

And the said resolution was adopted by the House.

Ordered-That Sir William Lyne and Mr. Deakin do prepare and bring in a Bill to carry out the foregoing resolution.

11. - Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
- Mr. Speaker resumed the Chair ; Mr. McDonald reported that the Committee had gone through the Bill and had agreed to the same without amendment.
- On the motion of Sir William Lyne the House adopted the Report.
- Sir William Lyne moved, That the Bill be now read a third time.

Question-put and resolved in the affirmative.-Bill read a third time.
