- 3. Public Servants over Age Limit Retired or Retained .- Mr. Bamford moved, pursuant to notice, That a Return be laid upon the Table showing-
 - (1) The number of officers in the Commonwealth Public Service who have been compulsorily retired upon reaching the age limit during the five years ending the 31st December,
 - (2) The number of officers (if any) retained in the service who have reached or are past the retiring age, giving the salaries paid to each of the officers retained (if any), and the salaries paid to those retired.

(3) The number of officers who were, on the 31st December last, over 60 years of age. [The number in each State in each case to be given.]

Question-put and resolved in the affirmative.

4. Australian Industries Preservation Bill (1907).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
