- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 PRIVILEGE—STATEMENT BY MR SPEAKER: Mr Speaker referred to the matters of privilege raised yesterday by Mr James. In regard to the first matter, relating to a speech by Mr Neil, Mr Speaker stated that no question of privilege was involved.

In relation to the second matter concerning the remarks made by Mr D. Rofe, Q.c., in the Queanbeyan Court of Petty Sessions on 5 April 1976, as reported in the *Canberra Times* of 6 April 1976, Mr Speaker referred to the privilege of freedom of speech in Parliament and the terms of the 9th Article of the Bill of Rights and the application of those provisions to the matter raised. In the present instance he was not satisfied that a *prima facie* case of breach of privilege existed and, further, the matter had not been raised at the earliest opportunity. Accordingly, the matter could not be given precedence over other business.

- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Jacobi and Mr Short—from certain citizens of Australia praying that the Government reverse the decision to cut 1975–76 overseas development assistance, reaffirm Australia's commitment of assistance of a minimum of 0.7% of G.N.P. and establish an independent statutory authority to administer such assistance.
 - Mr Martin and Mr A. P. Whitlam—from certain citizens of Australia praying that milk substitutes for children up to 6 years of age be restored to the Schedule of Pharmaceutical Benefits.
 - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
 - Mr Holten—from certain citizens of Myrtleford, Mount Beauty, Bright, Wandiligong, Wangaratta, Chiltern, Yarrawonga and Beechworth, Vic., praying that plans for a university at Albury-Wodonga be proceeded with.
 - Mr McLean—from certain citizens of Australia praying that payments under the National Employment and Training System be re-adjusted to the equivalent of the average adult male award wage.
 - Mr Neil—from certain citizens of Australia praying that the Australian immigration staff in Damascus be doubled to that which was operating in Beirut in peace time, and that the refugee provisions of Australia's immigration policy be applied.
 - Mr Simon—from certain electors of the Division of McMillan praying that the integrity and independence of the Australian Broadcasting Commission be maintained, no consideration be given to the placing of advertisements on the A.B.C. and a full-time Chairman to appointed to the Commission immediately.

Mr Wallis—from certain citizens of Whyalla, S.A., praying that the threatened closure of the shipbuilding industry in Whyalla be alleviated by facilitating construction at Whyalla of 2 vessels on order from the Australian National Line.

- 8 Message from the Governor-General—Assent to Bill: A message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name of Her Majesty, had assented to the following Bill:

7 April 1976—Message No. 31—Australia-Japan Foundation 1976.

9 EXPENDITURE—PROPOSED STANDING COMMITTEE: Mr Fraser (Prime Minister), pursuant to notice, moved—

(1) That a Standing Committee be appointed to:

- (a) consider any papers on public expenditure presented to this House and such of the estimates as it sees fit to examine;
- (b) consider how, if at all, policies implied in the figures of expenditure and in the estimates may be carried out more economically;
- (c) examine the relationship between the costs and benefits of implementing government programs, and
- (d) inquire into and report on any question in connection with public expenditure which is referred to it by this House.
- (2) That the committee consist of 6 members to be nominated by the Prime Minister, 5 members to be nominated by the Leader of the Opposition, and the Chairman of the Joint Committee of Public Accounts or his nominee.
- (3) That every nomination of a member of the committee be forthwith notified in writing to the Speaker.
- (4) That the members of the committee hold office as a committee until the House of Representatives expires by dissolution or effluxion of time.
- (5) That the committee elect as Chairman of the committee one of the members nominated by the Prime Minister.
- (6) That the committee elect a Deputy Chairman who shall perform the duties of the Chairman of the committee at any time when the Chairman is not present at a meeting of the committee, and at any time when the Chairman and Deputy Chairman are not present at a meeting of the committee the members present shall elect another member to perform the duties of the Chairman at that meeting.
- (7) That the committee have power to appoint sub-committees consisting of 5 or more of its members, and shall appoint the Chairman of each sub-committee who shall have a casting vote only, and refer to any such sub-committee any matter which the committee is empowered to examine.
- (8) That a majority of the members of a sub-committee constitute a quorum of that sub-committee.
- (9) That members of the committee who are not members of a sub-committee may take part in the public proceedings of that sub-committee but shall not vote or move any motion or constitute a quorum.
- (10) That the committee or any sub-committee have power to send for persons, papers and records.
- (11) That the committee have power to move from place to place and to sit during any recess.
- (12) That any sub-committee have power to move from place to place, adjourn from time to time and to sit during any recess, sitting or adjournment.
- (13) That the committee or any sub-committee have power to authorise publication of any evidence given before it and any document presented to it.
- (14) That 5 members of the committee constitute a quorum of the committee.
- (15) That the committee be provided with necessary staff, facilities and resources.
- (16) That the committee in selecting particular matters for investigation take account of the investigations of other Parliamentary committees and avoid duplication.
- (17) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
- (18) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.

- Debate adjourned (Mr Scholes), and the resumption of the debate made an order of the day for the next sitting.
- 10 Postponement of notice: Ordered—That notice No. 2, government business, be postponed until a later hour this day.
- 11 Customs Tariff Proposals No. 7 (1976): Mr Howard (Minister for Business and Consumer Affairs) moved Customs Tariff Proposals No. 7 (1976).
 - Debate adjourned (Mr Young), and the resumption of the debate made an order of the day for the next sitting.
- 12 STATES GRANTS (SCHOOLS) BILL 1976: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Question—put and passed—Bill read a second time.
