- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr E. G. Whitlam (Leader of the Opposition), Dr Edwards, Mr Haslem, Dr Klugman, Mr J. L. McMahon, Mr W. McMahon and Mr Wentworth—from certain citizens of Australia praying that the right of all trade union members to participate in ballots be guaranteed, voting in union elections be made compulsory and the re-introduction of the collegiate system of union elections be resisted.
 - Mr Lynch (Treasurer), Mr Newman (Minister for Repatriation), Mr Corbett, Dr Edwards, Mr Hurford and Mr Jarman—from certain citizens of Australia praying that the Government reverse the decision to cut 1975-76 overseas development assistance, reaffirm Australia's commitment of assistance of a minimum of 0.7% of G.N.P. and establish an independent statutory authority to administer such assistance.
 - Mr Uren (Deputy Leader of the Opposition), Mr J. L. McMahon, Mr Morris and Mr A. P. Whitlam—from certain citizens of Australia praying that a system of double income tax on personal incomes be not re-introduced.
 - Mr Bryant and Mr Morris—from certain citizens of Australia praying that milk substitutes for children up to 6 years of age be restored to the schedule of Pharmaceutical Benefits.
 - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
 - Mr Falconer—from certain electors of the Division of Bruce and other electorates praying that the reductions in payments to NEAT system trainees be re-considered.
 - Mr Giles—from certain citizens of South Australia praying that the House instruct the Standing Committee on the Environment to examine the boundaries of the proposed Kakadu National Park, N.T., with a view to including the catchments of the East and South Alligator Rivers within the Park.
 - Mr Giles—from certain electors of the Division of Angas praying that the assistance given to the education of children living in isolated districts be reviewed.
 - Mr Haslem—from certain citizens of Australia praying that the Australian Heritage Commission be appointed urgently and grants be given to community organisations concerned with conservation.
 - Mr Lucock—from certain residents of Port Macquarie, N.S.W., in terms similar to the last preceding petition.
 - Mr Jarman—from certain citizens of Australia praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.

10 Message from the Governor-General, Proposed additional expenditure for service of year, 1975–76—Appropriation Bill (No. 3) 1975–76: Message No. 37, dated 27 April 1976, from His Excellency the Governor-General was announced transmitting to the House of Representatives particulars of proposed additional expenditure from the Consolidated Revenue Fund for the service of the year ending on 30 June 1976, and recommending an appropriation of the Consolidated Revenue Fund accordingly.

Mr Lynch (Treasurer) presented a Bill for an Act to appropriate a sum out of the Consolidated Revenue Fund, additional to the sums appropriated by the Appropriation Act (No. 1) 1975-76, for the service of the year ending on 30 June 1976.

Bill read a first time.

Mr Lynch moved—That the Bill be now read a second time.

Debate adjourned (Mr Hurford), and the resumption of the debate made an order of the day for the next sitting.

11 Message from the Governor-General, Certain proposed additional expenditure 1975–76—Appropriation Bill (No. 4) 1975–76: Message No. 38, dated 27 April 1976, from His Excellency the Governor-General was announced transmitting to the House of Representatives particulars of certain proposed additional expenditure from the Consolidated Revenue Fund in respect of the year ending on 30 June 1976, and recommending an appropriation of the Consolidated Revenue Fund accordingly.

Mr Lynch (Treasurer) presented a Bill for an Act to appropriate a sum out of the Consolidated Revenue Fund, additional to the sum appropriated by the *Appropriation Act* (No. 2) 1975–76, for certain expenditure in respect of the year ending on 30 June 1976.

Bill read a first time.

Mr Lynch moved—That the Bill be now read a second time.

Debate adjourned (Mr Hurford), and the resumption of the debate made an order of the day for the next sitting.

12 TRADE PRACTICES AMENDMENT BILL 1976: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Ordered—That Mr Howard (Minister for Business and Consumer Affairs) be granted an extension of time.

Ouestion—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

Clauses 1 to 3, by leave, taken together, and agreed to, after debate.

On the motion of Mr Howard, the clause was omitted, and the following clause substituted:

- "4. Section 6 of the Principal Act is amended—
- (a) by omitting from paragraph (b) of sub-section (2) the words 'section 46, Part V (other than section 55)' and substituting the Act. words 'sections 46, 60 and 61, sub-sections 64 (3) and (4)'; and
- (b) by omitting from paragraph (h) of sub-section (2) the word and figures 'or 89 (7)'.".

Clauses 5 to 9, by leave, taken together, and agreed to, after debate.

Clause 10--

On the motion of Mr Howard, by leave, the following amendments were made together: Page 3, line 31, omit "and".

Page 3, after paragraph (c) insert the following paragraph:

"(ca) by omitting from sub-section (9) the words 'Subject to sub-section (10), where—' and substituting the word 'Where—'; and".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to, after debate.

Bill to be reported with amendments.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Howard, by leave, the House adopted the report, and, by leave, the Bill was read a third time.
