WEDNESDAY, 2 JUNE 1976

- 1 The House met, at 11.00 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr FitzPatrick, Mr J. L. McMahon and Mr Stewart—from certain citizens of Australia praying that grants to under-privileged schools in the Sydney inner city area be retained.
 - Mr Connolly and Mr Neil—from certain citizens of Australia praying that a Commission of Inquiry be initiated into the Aurukun Associates Agreement Act, no mining take place on the Aurukun Aboriginal Reserve until a full environmental impact study has been made and an export licence to the consortium concerned be refused until negotiations are held with the Aurukun people and an agreement has been reached.
 - Mr J. L. McMahon and Mr Morris—from certain citizens of Australia praying that social security payments be adjusted instantly and automatically with increases in the Consumer Price Index and certain other benefits be adjusted.
 - Mr Burr—from certain citizens of Australia praying that immediate steps be taken to support dairy farmers until the industry is stabilised.
 - Mr Carige—from certain electors of the Division of Capricornia praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Connolly—from certain citizens of Australia praying that the Australian Heritage Commission be appointed urgently and grants be given to community organisations concerned with conservation.
 - Mr Connolly—from certain citizens of Australia praying that all current woodchip export licences be cancelled, more funds be provided for research into the recycling of used packaged material and future applications for woodchip leases be preceded by an environmental inquiry.
 - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
 - Mr Falconer—from certain citizens of Australia praying that the Australian National Library be accessible to readers from 9.30 a.m. to 10.00 p.m. daily.
 - Mr Garland—from certain citizens of Australia praying that the means test on all aged pensions be abolished immediately.
 - Mr Hurford—from certain citizens of Australia praying that the decision to curtail the home mortgage interest tax deduction scheme be reconsidered and the benefits be upgraded by indexation.
 - Mr Morris—from certain citizens of Australia praying that a system of double income tax on personal incomes be not re-introduced.
 - Mr Morris—from certain citizens of Newcastle, N.S.W., praying that the Government place immediate orders with the Newcastle State Dockyard and implement the plan to build a graving dock in Newcastle.

Mr A. P. Whitlam—from certain citizens of Australia praying that the Government reverse the decision to cut 1975-76 overseas development assistance, reaffirm Australia's commitment of assistance of a minimum of 0.7% of G.N.P. and establish an independent statutory authority to administer such assistance. Petitions received.

Mr Uren addressed the House.

8 Customs Tariff Validation Bill 1976: Mr Howard (Minister for Business and Consumer Affairs) presented a Bill for an Act to provide for the Validation of certain Collections of Duties of Customs.

Bill read a first time.

Mr Howard moved—That the Bill be now read a second time.

Debate adjourned (Mr Bowen), and the resumption of the debate made an order of the day for the next sitting.

Message from the Governor-General: Message No. 62, dated 25 May 1976, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

The House resolved itself into a committee of the whole.

In the committee

Clause 1 agreed to.

Clause 2—

On the motion of Mr Ellicott (Attorney-General), the clause was omitted, and the following clause substituted:

- "2. (1) Sections 1, 2, 16A, 17 and 38 and the Schedule shall come Commenceinto operation on the day on which this Act receives the Royal Assent.
- "(2) Sections 28 and 29 shall be deemed to have come into operation on 5 January 1976.
- "(3) The remaining provisions of this Act shall come into operation on 1 July 1976.".

Clauses 3 to 16, by leave, taken together, and agreed to.

New clause-

On the motion of Mr Ellicott, the following new clause was inserted in the Bill:

"16a. Section 39 of the Principal Act is amended by omitting subsection (9) and substituting the following sub-section:—

Jurisdiction in matrimonial causes.

'(9) The jurisdiction conferred on or invested in a court by this section includes jurisdiction to hear and determine proceedings transferred to that court in accordance with this Act.';".

Clause 17—

On the motion of Mr Ellicott, the following amendment was made: Page 8, after paragraph (a) insert the following paragraph:

"(aa) by inserting in sub-section (3), after the word 'instituted' the words 'and proceedings transferred to that court in accordance with this Act';".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill to be reported with amendments.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Ellicott, by leave, the House adopted the report, and, by leave, the Bill was read a third time.
