- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 DEATH OF SENATOR THE HONOURABLE I. J. GREENWOOD: Mr Fraser (Prime Minister) referred to the death of Senator the Honourable I. J. Greenwood, and moved—That this House expresses its deep regret at the death, this day, of Senator the Honourable Ivor John Greenwood, Q.C., Senator for the State of Victoria from 1968, a Minister of the Crown from 1971 to 1972 and from 1975 to 1976, Deputy Leader of the Opposition in the Senate from 1972 to 1975, and Deputy Leader of the Government in the Senate from 1975 to 1976, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and the members of his family in their bereavement.
 - And Mr E. G. Whitlam (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Deputy Leader of the National Country Party of Australia) and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question—passed.

- 3 Suspension of sitting as mark of respect: As a mark of respect to the memory of the deceased Senator, the sitting was thereupon suspended until 8 p.m.
- 4 RESUMPTION OF SITTING: At 8 p.m., Mr Speaker resumed the Chair.
- 5 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Keating, Mr Morris and Mr A. P. Whitlam—from certain citizens praying that the independence of the Australian Broadcasting Commission be maintained, advertising on the A.B.C. be rejected, public funding of the Commission be developed and any general inquiries into broadcasting be conducted publicly.
 - Mr Morris and Mr A. P. Whitlam—from certain citizens praying that the M.V. Australian Trader be restored to the Tasmanian service.
 - Mr Ellicott (Attorney-General)—from certain citizens of Sydney, N.S.W., praying that steps be taken to withdraw any proposed regulation or repeal any regulation made under the Customs Act having the effect of imposing a quarantine on imported cheeses.
 - Mr E. L. Robinson (Minister for Post and Telecommunications)—from certain citizens praying that the Government reverse the decision to cut 1975–76 overseas development assistance and send some of our more productive cows to the Indian sub-continent.
 - Dr Cass—from certain students and associates of Melbourne University, Vic., praying that the indexed value of education spending be maintained and that other action be taken in connection with certain educational assistance schemes.
 - Mr Connolly—from certain citizens praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.

Dr Edwards—from certain citizens praying that support for child care be continued and expanded.

Mr Morris—from certain citizens praying that the 1976–77 Budget be re-drafted to provide for economic recovery within the guidelines laid down in the 1975–76 Budget.

Mr Morris—from certain citizens of Newcastle, N.S.W., praying that the Government place immediate orders with the Newcastle State Dockyard and implement the plan to build a graving dock in Newcastle.

Mr Young—from certain citizens praying that the Australian Assistance Plan be continued as recommended in the report tabled in Parliament on 4 March 1976.

Mr Young—from certain citizens praying that a total economic boycott of South Africa be implemented, all diplomatic and political links with that country be cut and victims of apartheid be offered immediate aid.

Mr Young—from certain citizens praying that the House call on Sir John Kerr to resign as Governor-General.
