- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Nixon (Minister for Transport), Mr Macphee (Minister for Productivity), Mr Abel, Mr Dobie and Mr Jones—from certain citizens praying that the continuation and growth of symphony or chestras throughout Australia been sured.
 - Mr McVeigh, Mr Martyr and Mr Wallis—from certain citizens praying that the recommendations of the Australian Council of Local Government Associations for the allocation of funds for roads be adopted and the Government's long-term policy be to provide 50 per cent of all funds for roads.
 - Mr FitzPatrick and Mr L. R. Johnson—from certain citizens praying that the independence of the Australian Broadcasting Commission be maintained, advertising on the A.B.C. be rejected, public funding of the Commission be developed and any general inquiries into broadcasting be conducted publicly.
 - Mr Graham and Mr W. McMahon—from certain citizens praying that the recommendations of the Commonwealth Bureau of Roads for the funding of local roads in New South Wales be adopted.

 - Mr Hurford—from certain citizens praying that the nomination of Ms Elizabeth Reid to the United Nations Secretariat for the Social and Economic Development Council be supported.
 - Mr L. R. Johnson—from certain citizens praying that increases in the Consumer Price Index be applied to age and invalid pensions and that any revision of the Consumer Price Index will not result in reductions in the value of future pensions.
 - Mr L. R. Johnson—from certain citizens praying that the decision to curtail the home mortgage interest tax deduction scheme be reconsidered and the benefits be upgraded by indexation.
 - Mr L. R. Johnson—from certain citizens praying that the freeze on the alienation of vacant Crown land in the Northern Territory be extended and the Aboriginal Land Rights (Northern Territory) Bill 1976 be amended.

10 CONSTITUTION ALTERATION (SENATE CASUAL VACANCIES) BILL 1977: Mr Ellicott (Attorney-General), by leave, presented a Bill for an Act to alter the Constitution so as to ensure so far as practicable that a Casual Vacancy in the Senate is filled by a Person of the same Political Party as the Senator chosen by the People and for the balance of his Term.

Bill read a first time.

Mr Ellicott moved—That the Bill be now read a second time.

Debate adjourned (Mr E. G. Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

11 CONSTITUTION ALTERATION (RETIREMENT OF JUDGES) BILL 1977: Mr Ellicott (Attorney-General), by leave, presented a Bill for an Act to alter the Constitution so as to provide for Retiring Ages for Judges of Federal Courts.

Bill read a first time.

Mr Ellicott moved—That the Bill be now read a second time.

Debate adjourned (Mr E. G. Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

12 CONSTITUTION ALTERATION (REFERENDUMS) BILL 1977: Mr Ellicott (Attorney-General), by leave, presented a Bill for an Act to alter the Constitution so as to allow Electors in Territories, as well as Electors in the States, to vote at Referendums on Proposed Laws to alter the Constitution.

Bill read a first time.

Mr Ellicott moved—That the Bill be now read a second time.

Debate adjourned (Mr E. G. Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.
