## THURSDAY, 2 JUNE 1977

  - Mr Bungey—from certain citizens praying that the Government's long-term policy be to provide 50 per cent of funds for roads, that funds under the Aged Persons Homes Act be distributed more equitably and that television services be extended to remote areas.

3 WANT OF CONFIDENCE IN THE GOVERNMENT—NOTICE OF MOTION: Mr E. G. Whitlam (Leader of the Opposition) gave notice of a motion of want of confidence in the Government which he proposed to move at the next sitting.

Suspension of standing orders: Mr Anthony (Acting Prime Minister) moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving forthwith the motion of want of confidence of which he has given notice for the next sitting.

Question—put and passed, with the concurrence of an absolute majority.

- 4 WANT OF CONFIDENCE IN THE GOVERNMENT: Mr E. G. Whitlam (Leader of the Opposition) moved—That this House has no confidence in the Fraser Government because of:
  - (1) Its creation of the highest unemployment since the Great Depression;
  - (2) Its callous disregard for the victims of its economic policies including the unemployed and their families;
  - (3) Its contempt for the law and defiance of the High Court in contriving to withhold unemployment benefits from eligible persons, and
  - (4) The inability of the Treasurer to grasp and adequately respond to the grave social and economic consequences of his excessively severe economic measures.
