## THURSDAY, 22 SEPTEMBER 1977

- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Acting Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Armitage, Sir William McMahon and Mr Neil—from certain citizens praying that the part of a deceased person's estate which passes to the surviving spouse be free from federal estate duty.
  - Mr Cohen, Dr Klugman and Mr MacKenzie—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
  - Mr Chapman—from certain citizens praying that the Family Law Act be amended to enable the enforcement of warrants for the return of children to the parent having lawful custody.
  - Mr Cohen—from certain citizens praying that steps be taken to end commercial whaling.
  - Mr Connolly—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.
  - Mr Falconer—from certain citizens praying that federal funding for education through the Schools Commission be maintained at a growth rate of 2% and that certain other action be taken in connection with education expenditure.
  - Mr J. L. McMahon—from certain residents of Sydney praying that the interest rate on loans to State housing organisations not be increased.

Mr Short—from certain citizens praying for legislation forbidding the performance of abortions in the A.C.T.
