## No. 49

### WEDNESDAY, 12 OCTOBER 1977

- 1 The House met, at 2.55 p.m. The Acting Speaker (Mr Lucock) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Anthony, Dr Edwards and Mr Morris—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
  - Mr MacKellar, Mr J. L. McMahon and Sir William McMahon—from certain citizens praying that the part of a deceased person's estate which passes to the surviving spouse be free from federal estate duty.
  - Mr Anthony—from certain members of the Order of the White Cross praying that action be taken to facilitate the release of Rudolf Hess from prison.
  - Mr Fry—from certain citizens praying that the Special United Nations Session on Disarmament in 1978 be supported, the adoption of peace studies and research be encouraged and nuclear-free zones in the Indian and Pacific Oceans be supported.
  - Mr Fry—from certain citizens praying that steps be taken to end commercial whaling.
  - Mr Hurford—from certain citizens praying that in any new Housing Agreement, States' Housing Authorities not be forced to charge market rents or bear market interest rates.
  - Mr Hurford—from certain citizens praying for recognition of the work of a certain part-time member of the Schools Commission.
  - Mr Hyde—from certain citizens praying for the reversal of the decision withdrawing financial assistance from students of non-State tertiary institutions.
  - Mr Jarman—from certain citizens praying that the imperial system of weights and measures be restored.
  - Mr Morris—from certain citizens praying that the Council of the Australian National Gallery have the right to purchase major works of art without Cabinet intervention and that the decision to reject the Council's recommendation to purchase *Grand Nu* be revoked.
  - Mr Morris—from certain citizens praying that a system of double income tax on personal incomes not be introduced.
  - Mr Sinclair—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.

- 6 ANALYTICAL LABORATORY, PYMBLE, N.S.W.—APPROVAL OF WORK: Mr McLeay (Minister for Construction), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Construction of an analytical laboratory at Pymble, N.S.W.

Question-put and passed.

7 INDUSTRIES ASSISTANCE COMMISSION—REPORT—PASSENGER MOTOR VEHICLES—PAPER NOTED: The order of the day having been read for the resumption of the debate on the motion of Mr Sinclair (Leader of the House)—That the House take note of the paper (*presented on 6 October 1977*), viz.:

Industries Assistance Commission—Report—Passenger motor vehicles, dated 12 September 1977—

Debate resumed.

Ordered-That Mr Young be granted an extension of time.

Debate continued.

Question-put and passed.

8 STATES GRANTS (HOUSING ASSISTANCE) BILL 1977: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Mr Bryant rising to address the House-

Closure: Mr D. M. Cameron moved-That the question be now put.

- Message from the Governor-General: Message No. 59, dated 5 October 1977, from His Excellency the Governor-General was announced recommending an appropriation of revenue and moneys for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

Mr Newman (Minister for Environment, Housing and Community Development) moved—That the Bill be now read a third time.

Mr Bryant rising to address the House-

Question—That the question be now put—put and passed—Mr Bryant dissenting.

And the question—That the Bill be now read a third time—was put accordingly, and passed—Bill read a third time.

9 APPROPRIATION BILL (No. 1) 1977-78: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.
