- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 RETURN TO WRIT—CUNNINGHAM DIVISION: Mr Speaker announced that he had received a return to the writ which he had issued on 8 September 1977 for the election of a Member to serve for the Electoral Division of Cunningham, in the State of New South Wales, to fill the vacancy caused by the death of the Honourable Reginald Francis Xavier Connor, and that, by the endorsement on the writ, it was certified that Stewart John West had been elected.
- 3 AFFIRMATION OF ALLEGIANCE BY MEMBER: Stewart John West was introduced, and made and subscribed the affirmation of allegiance required by law.
- 4 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Armitage, Mr FitzPatrick, Mr Gillard, Mr James, Mr Lucock, Mr Lusher, Mr O'Keefe and Mr Wentworth—from certain volunteer firemen of the New South Wales Fire Brigade Service praying that income tax relief be provided on the earnings of N.S.W. volunteer firemen.
  - Mr Connolly—from certain citizens praying that there be more research into all fields of energy sources.
  - Mr L. R. Johnson—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
  - Mr L. R. Johnson—from certain citizens praying that public debate on a replacement constitution be encouraged, a directly elected constitutional convention be convened and a referendum be conducted on its resolutions.
  - Mr Sainsbury—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.
  - Mr E. G. Whitlam-from certain citizens praying that the recommendations of the Committee of Inquiry into Public Libraries be implemented.

- 6 SUSPENSION OF STANDING ORDERS MOVED: Mr Hayden moved—That so much of the standing orders be suspended as would prevent the honourable Member for Oxley moving that this House deplores the Prime Minister's inability to understand a simple question on economic policy, indicating his inability to understand and adequately respond to advice which statutory bodies are required to make to Parliament, thus reflecting the reasons why Government economic policies are so inappropriate and damaging to the nation.
