- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (MR C. W. RUSSELL): Mr Speaker informed the House of the death, on 21 October, of Mr Charles Wilfred Russell, a Member of this House for the Division of Maranoa from 1949 to 1951.
 - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Anthony, Mr Jones, Mr Morris and Mr E. G. Whitlam—from certain volunteer firemen of the New South Wales Fire Brigade Service praying that income tax relief be provided on the earnings of N.S.W. volunteer firemen.
 - Dr Klugman and Mr Morris—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
 - Mr Connolly—from certain citizens praying that there be no mining of uranium.
 - Mr Dobie—from certain citizens praying that expenditure on welfare, health and public education be maintained or increased.
 - Mr L. R. Johnson—from certain citizens praying for a public inquiry to ensure that Australia's internal and international air fares are fairly priced.
 - Mr L. R. Johnson—from certain citizens praying that public debate on a replacement constitution be encouraged, a directly elected constitutional convention be convened and a referendum be conducted on its resolutions.
 - Dr Klugman—from certain members of the Service Station Association of N.S.W. Ltd and others praying that in implementing the findings of the Royal Commission on Petroleum the needs of the motoring public and the retail petroleum industry be given every consideration.
 - Dr Klugman—from certain citizens praying that education funding be restored to the level advocated in the 1975 Schools Commission report.
 - Mr Morris—from certain citizens praying that a system of double income tax on personal incomes be not introduced.
 - Mr Neil—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.
 - Mr Street—from certain citizens praying that payments of abortion claims under the Medical Benefits Schedule cease except for those abortions carried out in hospitals as a certified medical procedure to prevent the death of the mother and that certain other action be taken in connection with pregnancy help services.
