- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITORS: Mr Speaker informed the House that a Parliamentary Delegation from New Zealand, led by the Honourable H. R. Lapwood, M.P., Minister of Tourism, was present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a very warm welcome.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Aldred, Mr Jarman and Mr Shipton—from certain members and ex-members of the citizens forces of Australia praying for the resumption of the award of several distinctive reserve forces decorations and medals for long service and good conduct.
 - Mr Baume—from certain teachers of New South Wales praying that the Income Tax Assessment Act be amended to exempt country teachers from paying tax on the value of subsidised housing.
 - Mr D. M. Cameron—from certain citizens praying that lone fathers receive a pension on the same basis as supporting mothers.
 - Mr Dobie—from certain citizens praying that item 6469 be removed from the standard medical benefits table.
 - Mr L. R. Johnson—from certain citizens praying for the provision of funds for the construction and maintenance of an aged persons complex in the Electoral Division of Hughes.
 - Mr Katter—from certain residents of Greenvale, Qld, praying that the value of subsidised accommodation and other concessions provided by employers not be taxed.
 - Mr Morris—from certain citizens praying that the \$6 permissible income limit on unemployment benefits be raised.
 - Mr Neil—from certain electors of the Division of St George praying that the recommendations of the Royal Commission on Human Relationships be rejected.
 - Mr Shack—from certain citizens praying that Government benefits under Schedule 6469 not be removed.
 - Mr Short—from certain citizens of Ballarat, Vic., praying that the Australian Broadcasting Commission not be permitted to screen the television series *SOAP*. Petitions received.
- 4 Suspension of standing orders—Motion of want of confidence in the Government: Mr Hayden (Leader of the Opposition) having given a notice of motion—
 - Mr Sinclair (Leader of the House), by leave, moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving forthwith the motion of want of confidence in the Government of which he has given notice for the next sitting.

5 WANT OF CONFIDENCE IN THE GOVERNMENT: Mr Hayden (Leader of the Opposition) moved—That this House expresses its want of confidence in the Fraser Government because of the conspiracy by Ministers—including the Prime Minister—to mislead the Parliament, to mislead the McGregor Royal Commission and the Australian people with regard to the Queensland Electoral Distribution.
