## TUESDAY, 10 OCTOBER 1978

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DEATH OF HIS HOLINESS POPE JOHN PAUL: Mr Fraser (Prime Minister) referred to the death of His Holiness Pope John Paul, and moved—That the House notes the death, on 29 September 1978, of His Holiness Pope John Paul, and expresses its profound regret at his passing.
  - And Mr Hayden (Leader of the Opposition) having seconded the motion, and all Members present having risen, in silence—

    Question—passed.
- 3 DISTINGUISHED VISITORS: Mr Speaker informed the House that delegates attending the 4th Australasian Parliamentary Seminar were present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a very warm welcome.
- 4 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Johnson and Mr Kerin—from certain citizens praying for the replacement of the 1978-79 Budget by a budget which increases the level of economic activity, lowers unemployment, assists the disadvantaged and revives business and consumer confidence.
  - Mr Anthony, Mr Goodluck and Mr Neil—from certain citizens praying for the rejection of any legislation introducing annual adjustments of pension rates.
  - Mr Lloyd, Mr Street and Mr Yates—from certain citizens praying that the Medical Benefits Schedule be amended to preclude payment of benefits for abortions.
  - Mr N. A. Brown and Mr Bryant—from certain citizens praying that Radio 3CR Melbourne be required to adhere to the broadcasting standards laid down for all other radio stations and that legislation be enacted against incitement to racial hatred and violence.
  - Mr Howard and Mr L. R. Johnson—from certain members of the Sydney University Post Graduate Representative Association and others praying that Commonwealth postgraduate research awards be adjusted annually in line with the consumer price index and not be taxed.
  - Mr Kerin and Dr Klugman—from certain citizens praying that proposed changes to Medibank not be implemented and that there be consultation with the trade unions and the community.

Mr Anthony-from certain members of the Order of the White Cross International praying for the banning of the use of DDT and other pesticides in agriculture and chemical substances in food and beverages.

Mr Anthony—from certain members of the Order of the White Cross International praying for the official recognition of the Sovereign Humanitarian Mission State Aeterna Lucina.
