# HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

## No. 73

## WEDNESDAY, 22 NOVEMBER 1978

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Armitage, Mr Humphreys, Dr Jenkins, Mr L. K. Johnson, Mr L. R. Johnson, Mr B. O. Jones, Mr Kerin and Mr Martin—from certain citizens praying for the reversal of current economic strategies.
  - Mr Aldred, Mr Bourchier, Mr Burns, Mr Lynch, Mr Macphee, Mr Nixon and Mr Street—from certain citizens praying that the Medical Benefits Schedule be amended to preclude payment of benefits for abortions.
  - Mr Cadman, Mr Dobie, Mr Johnston and Mr I. L. Robinson—from certain citizens praying for the prohibition of pornographic material involving children.
  - Mr Hayden and Mr Kerin—from certain citizens praying that proposed changes to Medibank not be implemented and that there be consultation with the trade unions and the community.
  - Mr L. R. Johnson and Mr Killen—from certain citizens praying for the award of a medal to members of the World War II *Jaywick* and *Rimau* commando expeditions.
  - Mr J. L. McMahon and Mr Ruddock—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.
  - Mr Porter and Mr Wallis—from certain citizens praying for continued and increased Federal subsidies to maintain all existing South Australian country rail services.
  - Mr Armitage—from certain citizens praying for the replacement of the 1978–79 Budget by a budget which increases the level of economic activity, lowers unemployment, assists the disadvantaged and revives business and consumer confidence.
  - Dr Blewett—from certain citizens praying that the question of cheaper airfares between Australia and the United Kingdom be resolved forthwith and that Laker Airways be permitted to operate from all Australian capital cities on a regular basis.
  - Mr N. A. Brown—from certain citizens praying that Radio 3CR Melbourne be required to adhere to the broadcasting standards laid down for all other radio stations and that legislation be enacted against incitement to racial hatred and violence.
  - Mr Cadman—from certain citizens praying that the post office at St Albans, N.S.W., not be closed.
  - Mr E. C. Cameron—from certain electors of the Electoral Division of Indi praying that land not necessary for development by the Albury-Wodonga Development Corporation be released from compulsory acquisition.
  - Mr Cohen—from certain citizens from the central coast region of N.S.W. praying that licences be granted to allow the installation of suitably located translator stations to improve the poor television reception in the central coast area of N.S.W.

- Mr Fry—from certain citizens praying that provisions for membership of student bodies at the Australian National University and the Canberra College of Advanced Education not be altered.
- Mr Giles—from certain citizens praying that immediate steps be taken to end commercial whaling.
- Mr Graham—from certain citizens praying that the position of staff elected commissioner of the Australian Broadcasting Commission continue and that the election of a new commissioner proceed.
- Mr L. R. Johnson-from certain citizens praying that indirect tax measures, such as a retail turnover tax or a value added tax, not be introduced.
- Mr L. R. Johnson—from certain citizens praying that an additional reactor not be constructed at the Australian Atomic Energy Establishment at Lucas Heights, N.S.W.
- Mr O'Keefe—from certain citizens praying that lone fathers receive a pension on the same basis as supporting mothers.
- Mr Simon—from certain citizens praying that any request from Jacob Prai and Otto Ondowame for political asylum in Australia be approved.
- Mr Thomson—from certain citizens praying that pensions be increased twice yearly in line with rises in the consumer price index.

- 3 SUSPENSION OF STANDING ORDERS—MOTION OF CENSURE OF THE GOVERNMENT: Mr Hayden (Leader of the Opposition) having given a notice of motion—
  - Mr Sinclair (Leader of the House), by leave, moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving forthwith the motion of censure of the Government of which he has given notice for the next sitting.

Question—put and passed.

Mr Sinclair informed the House that he accepted the notice of motion as a motion of censure of the Government for the purposes of standing order 110.

- 4 MOTION OF CENSURE OF THE GOVERNMENT: Mr Hayden (Leader of the Opposition) moved—That this House censures the Government for—
  - (1) economic incompetence in creating the worst recession since the Great Depression;
  - (2) perservering with policies which will aggravate the serious unemployment problem especially among the young;
  - (3) the breaking of solemn promises made to the electorate;
  - (4) the succession of scandals involving the Government arising from Ministerial improprieties, and
  - (5) the neglect of key areas of social responsibility.

Debate ensued.

- Mr Howard (Treasurer) moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "this House reprimands the Leader of the Opposition for—
  - (1) his failure to properly address any of the substantial issues facing Australia;
  - (2) demeaning the House by obsessive personal attacks;
  - (3) belittling the House by unwarranted and careless attacks on the Speaker and hence Parliament as an institution, and
  - (4) attempting to disguise the left wing policies and trends within the Labor Party".

Clause 10-

- Page 9, lines 19-22, omit all words after "him" to the end of proposed subsection (3), substitute "during that grant year unless-
  - (a) the amount of all his export earnings in that grant year exceeds \$25,000;
  - (b) in respect of export earnings consisting of consideration for the disposal of eligible industrial property rights or eligible knowhow, such earnings exceed \$10,000; or
  - (c) in respect of earnings in relation to the supply of eligible tourist services, such earnings exceed eligible expenditure.".

Page 9, omit sub-section (5) of proposed section 14, substitute the following sub-section:

"'(5) A reference in paragraph (c) of sub-section (3) to earnings from eligible tourist services is a reference to payments made by persons normally resident outside Australia, whether such payments are made inside or outside Australia.".

Clause 17, page 12, line 23, omit "is", substitute "he knows to be, or should reasonably be expected to know to be".

Clause 19, page 13, line 17, after "year" add "and includes a refusal to consider a claim under sub-section 13 (4) or 13 (5)".

Debate continued.

Amendments negatived.

Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr Giles reported accordingly.

On the motion of Mr Anthony (Minister for Trade and Resources), the House adopted the report, and, by leave, the Bill was read a third time.

24 ADJOURNMENT: Mr Anthony (Minister for Trade and Resources) moved—That the House do now adjourn.
