- 1 The House met, at 3.07 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITOR: Mr Speaker informed the House that His Royal Highness The Prince of Wales was within the precincts. With the concurrence of Members, His Royal Highness was provided with a seat beside the Speaker's Chair. On behalf of the House, Mr Speaker extended to His Royal Highness a sincere, cordial and loyal welcome.
- 3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Adermann, Mr Anthony, Mr D. M. Cameron, Mr Cohen, Mr Humphreys, Mr Keating, Mr Martin, Mr Morris, Mr O'Keefe, Mr Sainsbury, Mr Scholes and Mr Short—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Dobie, Mr Hunt, Mr Innes, Mr J. L. McMahon, Mr Scholes and Mr Simonfrom certain citizens praying that the House reject the motion of the honourable Member for Hume concerning medical benefits for abortion and support abortion as a claimable item under all health benefits.
 - Mr Dobie, Mr Hunt, Mr L. R. Johnson, Mr Johnston, Mr MacKellar and Mr Shipton—from certain citizens praying that the medical benefits schedule be amended to preclude payment of benefits for abortions.
 - Mr Cairns, Mr D. M. Cameron, Dr Everingham and Mr McVeigh—from certain citizens praying that legislation be introduced to prevent payment of medical benefits for unnecessary abortions.
 - Mr L. R. Johnson and Mr Scholes—from certain citizens praying for the resignation of Members who have not honoured an election undertaking to retain twiceyearly adjustments of social security pensions in accordance with movements in the consumer price index.
 - Mr Aldred—from certain citizens praying that the taxation law be amended to permit registered tax agents to trade for a full year and lodge income tax returns at the close of the respective tax year.
 - Mr Anthony—from certain citizens praying for the rejection of any legislation introducing annual adjustments of pension rates.
 - Mr Burns—from certain citizens praying that the imperial system of weights and measures be restored.
 - Mr Cohen—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.

- Mr Dobie—from certain citizens praying for the prohibition of pornographic material involving children.
- Mr Dobie—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
- Mr Hodges—from certain citizens praying that pensions be increased twice yearly in line with rises in the consumer price index.
- Mr Howard—from certain citizens praying for the award of a medal to members of the World War II Jaywick and Rimau commando expeditions.
- Mr L. R. Johnson—from certain citizens praying for the replacement of the 1978–79 Budget by a budget which increases the level of economic activity, lowers unemployment, assists the disadvantaged and revives business and consumer confidence.
- Mr L. R. Johnson—from certain citizens praying that the decision not to establish a National Natural Disaster Insurance Scheme be reconsidered.
- Mr L. R. Johnson—from certain citizens praying that greater funds be provided to the Australian Broadcasting Commission and that a staff-elected Commissioner be reappointed.
- Mr Johnston—from certain citizens praying that Parliament debate the Report of the Royal Commission on Human Relationships, facilitate public debate and take certain other action in connection with the Report.
- Mr Katter—from certain citizens praying that the decision in the 1978–79 Budget to increase fuel charges on primary producers be reconsidered.
- Dr Klugman—from certain electors of New South Wales praying that compensation benefits paid to injured Commonwealth Government employees be increased and then adjusted automatically.
- Mr Viner—from certain citizens praying that the importation of seal products be prohibited and that a protest be sent to the Canadian Government objecting to the needless slaughter of the Harp Seal.
