- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Armitage, Mr Bowen, Mr Carlton, Mr Connolly, Dr Edwards, Mr Ellicott, Mr Gillard, Mr James, Mr C. K. Jones, Mr Lusher, Mr MacKellar, Mr L. B. McLeay, Mr Morris, Mr O'Keefe and Mr West—from certain residents of New South Wales praying that the 1980 level of education expenditure to Government schools be restored and increased in real terms.
 - Dr Edwards, Mr Fife, Mr L. R. Johnson, Mr Lusher and Mr L. B. McLeay—from certain electors of New South Wales praying that the *Commonwealth Employees (Employment Provisions) Act* 1977 be repealed.
 - Dr Everingham—from certain electors of Queensland in the same terms as the last preceding petition.
 - Mr Bourchier and Mr MacKellar—from certain citizens praying that a humane policy be adopted to assist refugees to enter Australia.
 - Mr Cotter and Mr Martyr—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Cotter and Mr Martyr—from certain citizens praying that the National Health Scheme patient contribution rate not be increased.
 - Mr Hurford and Mr Wallis—from certain citizens praying that subsidies to preschools be increased to provide adequate pre-school services in South Australia.
 - Mr Lloyd and Mr Martyr—from certain citizens praying that the National Women's Advisory Council be abolished.
 - Mr Morris and Mr Shipton—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Carlton—from certain citizens praying that positive policies be adopted to reduce unemployment and that certain social security benefits be granted.
 - Mr Connolly—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Fife—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Ruddock—from certain citizens praying that major traditional Aboriginal land areas be resumed from the States eventually to become defined Aboriginal community co-operatives.
 - Mr West—from certain citizens praying that the proposal to increase the marine radio licence fee be reconsidered.
 - Mr West—from certain citizens praying that the decision to remove the tool allowance for pre-apprenticeship training schemes be reconsidered.

- 3 FUNERAL OF EARL MOUNTBATTEN OF BURMA—AUSTRALIAN REPRESENTATION: Mr Fraser (Prime Minister) informed the House that Australia would be represented at the funeral of the late Earl Mountbatten of Burma by His Excellency the Governor-General and that His Excellency would be accompanied by His Excellency the Governor of New South Wales, Senator Carrick (Minister for Education), Mr Uren and Mr Keys, National President of the Returned Services League. Sir Gordon Freeth, Australian High Commissioner in London, would also attend.
 - Mr Fraser also informed the House that, during the absences of the Governor-General and the Governor of New South Wales, the Governor of Tasmania would be sworn

as Administrator.

- 5 ANZAC—Use of word—Ministerial statement: Mr Macphee (Minister for Productivity), by leave, made a ministerial statement informing the House of relaxed circumstances under which the word ANZAC may be used in relation to entertainments held on Anzac Day.

Mr Hurford, by leave, also made a statement in connection with the matter.

6 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—FAMILY LIVING STANDARDS: Mr Speaker informed the House that Mr Hayden (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The decline in family standards of disposable income, security, food, housing and living quality since December 1975".

The proposed discussion having received the necessary support—

8 PUBLIC WORKS COMMITTEE—REPERENCE OF WORK—BRISBANE INTERNATIONAL AIRPORT REDEVELOPMENT—INITIAL WORKS OF PHASE 1: Mr Groom (Minister for Housing and Construction), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act* 1969, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for consideration and report: Redevelopment of Brisbane International Airport—Initial works of phase 1.

Mr Groom presented plans in connection with the proposed work.
