7 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—RIGHT OF FREE ASSEMBLY: Mr Speaker informed the House that Mr Bowen (Deputy Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The Government's failure to fulfil its responsibilities to guarantee all Australians the right of free assembly".

The proposed discussion having received the necessary support—

Mr Bowen addressed the House.

Discussion ensued.

8 AIR NAVIGATION (CHARGES) AMENDMENT BILL 1979: Mr Nixon (Minister for Transport), pursuant to notice, presented a Bill for an Act to amend the Air Navigation (Charges) Act 1952, and for related purposes.

Bill read a first time.

Mr Nixon moved—That the Bill be now read a second time.

Debate adjourned (Mr Morris), and the resumption of the debate made an order of the day for the next sitting.

9 DEFENCE FORCE (RETIREMENT AND DEATH BENEFITS AMENDMENTS) BILL (No. 2) 1979: Mr Killen (Minister for Defence), pursuant to notice, presented a Bill for an Act to amend the Defence Forces Retirement Benefits Act 1948 and the Defence Force Retirement and Death Benefits Act 1973.

Bill read a first time.

Mr Killen moved—That the Bill be now read a second time.

Debate adjourned (Mr Morris), and the resumption of the debate made an order of the day for the next sitting.

10 COMMONWEALTH SERUM LABORATORIES AMENDMENT BILL 1979: Mr Killen (Minister for Defence), for Mr Hunt (Minister for Health), pursuant to notice, presented a Bill for an Act to amend the Commonwealth Serum Laboratories Act 1961.

Bill read a first time.

Mr Killen moved—That the Bill be now read a second time.

Debate adjourned (Mr Morris), and the resumption of the debate made an order of the day for the next sitting.

- 12 STATES GRANTS (ROADS) AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Morris who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that the level of funds provided in the Bill for road purposes in 1979–80—
 - demonstrates that the Commonwealth's share of expenditure on road construction and maintenance, expressed in real terms, has seriously declined since the Fraser Government came to power and will further decline, whereas Federal revenue from fuel taxes and levies has more than doubled in the same period and will further increase;
 - (2) ignores the urgent necessity to accelerate road construction and maintenance programs designed to improve the quality of the Australian road system as a vital component of the national economy;
 - (3) fails to pursue policies designed to increase employment opportunities, and
 - (4) does not develop a responsible transport energy conservation program".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.
