 - Mr Connolly and Mr Graham—from certain citizens praying that the National Women's Advisory Council be maintained and Federal Government support for its activities be increased.
 - Mr Falconer and Mr Howe—from certain citizens praying that access to East Timor be obtained for Australian aid agencies and that certain other action in relation to immigration from East Timor be taken.
 - Dr Blewett—from certain citizens praying that Aborigines and other racial and cultural groups be acknowledged in any representation of the Australian community or promotions such as "Have a Go, Australia" be stopped altogether.
 - Mr Braithwaite—from certain citizens praying that the proposal to increase the marine radio licence fee be reconsidered and that the regulation allowing the use of CB radio in marine situations be rescinded.
 - Mr Bungey—from certain citizens praying that the application by South Western Telecaster Ltd for a broadcasting licence in the Mandurah-Pinjarra area be granted.
 - Mr Bungey—from certain citizens praying that the National Health Scheme patient contribution rate not be increased.
 - Mr D. M. Cameron—from certain citizens praying that the imperial system of weights and measures be restored.
 - Dr Cass—from certain citizens praying that recognition be given to the contribution of the Trade Union Movement to the development of Australia and the living standards of its citizens.
 - Dr Cass—from certain citizens praying that a humane policy be adopted to assist refugees to enter Australia.
 - Mr Innes—from certain citizens praying that action be taken to have telephone subscribers in the 047 zone included in the Sydney telephone district.

 - Mr Kerin—from certain citizens praying that positive policies be adopted to reduce unemployment and that certain social security benefits be granted.
