- 12 THIRTY-FIVE HOUR WEEK: Mr Viner (Minister for Employment and Youth Affairs), pursuant to notice, moved—That this House is of the opinion that there should not be a general 35 hour week in Australian industry because—
 - (1) a shorter working week will have damaging consequences for Australian industry, especially in the export market, and
 - (2) the resources of the nation, including our workforce, should be used to generate more jobs and get the economy fully employed rather than trying to force Australian industry into a shorter working week.

 - (1) any substantial reduction in working hours is gradually implemented, and in circumstances in which the process of change can be borne by the economy, and
 - (2) attempts are not made by either employees or employers to translate reduced working time into increased wages by increasing hours of overtime,

but asserts its strong belief that the restoration of full employment will also require a reversal of the disastrous stagflationary fiscal and monetary policies of the Fraser Government by the adoption of alternative policies designed to simultaneously stimulate economic activity and reduce inflation".
