- 1 The House met, at 2.45 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
 - 2 JOINT SITTING—CHOICE OF SENATOR—STATEMENT BY MR SPEAKER: Mr Speaker informed the House that, in accordance with the provisions of the *Senate (Representation of Territories) Act 1973*, at a joint sitting held in the Senate Chamber at 2.15 p.m. this day, Margaret Elizabeth Reid was chosen to hold the place in the Senate rendered vacant by the death of Senator John William Knight, a Senator for the Australian Capital Territory.
 - 3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr B. O. Jones, Mr C. K. Jones, Mr J. L. McMahon and Mr Morris—from certain citizens praying that any proposal to sell Trans Australia Airlines be rejected.
 - Mr Howe and Dr Jenkins—from certain citizens praying that any proposal to deny unemployment benefits to unemployed persons under 18 years of age be unconditionally withdrawn and that certain other action be taken in regard to unemployment benefits and employment policies.
 - Mr J. L. McMahon and Mr Mountford—from certain citizens praying that funding of children's services be restored to at least the real value of funding allocated in the 1975-76 Budget and future allocations be spent in full for the purposes designated.
 - Mr Bowen—from certain residents of the Electoral Division of Kingsford-Smith praying that the total education expenditure for 1980-81 for government schools and colleges be restored and substantially increased.
 - Mr R. J. Brown—from certain residents of New South Wales praying that the allocation of funds for government school programs be restored and substantially increased.
 - Mrs Child—from certain citizens praying that sanitary products for women be brought under the scrutiny of the Australian Drug Evaluation Committee and certain other actions be taken in regard to the possible threat posed to the health of women by toxic shock syndrome.
 - Mr Connolly—from certain citizens praying that section 79 (1) of the Family Law Act be amended to allow Family Courts to be made open to the public and to permit publication of the details of their proceedings, provided that the names of parties and other identifying information are prohibited from disclosure.
 - Mr Cowan—from certain citizens praying that any proposal to legislate for the establishment of plant breeder's rights in Australia be rejected.
 - Mr Jull—from certain citizens praying that the National Women's Advisory Council be abolished.
 - Mr Kerin—from certain citizens praying that any proposal to legislate for the establishment of plant variety rights in Australia be rejected.

Mr McLeay—from certain citizens praying that specific grants for the community health program in New South Wales be maintained at the current level.

Mr McLeay—from certain citizens praying that there be no extension of Kingsford-Smith Airport, Sydney, N.S.W.

Mr J. L. McMahon—from certain citizens praying that the House recognise the importance of the hotel industry and that any proposal to increase the excise on beer be rejected.

Sir William McMahon—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.

Mr Porter—from certain residents of Butler Tanks, S.A., praying that the right to sort all mail addressed to Butler Tanks be returned to the Butler Tanks Post Office.

Mr Ruddock—from certain citizens praying that militant unions not be permitted to hold the country to ransom and that a forceful and resolute stand be taken against union militancy.

- 7 AUSTRALIAN CAPITAL TERRITORY—JOINT COMMITTEE—REPORT—STATEMENT BY MEMBER:
Mr Fry (Acting Chairman) presented the following report from the Joint Committee on the Australian Capital Territory:

Ordered—That the report be printed.

Mr Fry, by leave, made a statement in connection with the report.

- 8 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—HOSPITAL SERVICES AND MEDICAL BENEFITS:

Mr Deputy Speaker informed the House that Dr Blewett had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Government to honour its promise to maintain free public hospital provision and universal Commonwealth medical benefits".

The proposed discussion having received the necessary support—

Dr Blewett addressed the House.

Discussion ensued.

Discussion concluded.

- 9 SUSPENSION OF STANDING ORDERS—GENERAL BUSINESS NOTICE: Mr Moore (Minister for Business and Consumer Affairs), by leave, moved—That so much of the standing orders be suspended as would prevent notice No. 47, general business, being called on forthwith.

Question—put and passed.

- 10 SPIRITS REGULATIONS—AMENDMENT TO REGULATION 9B—DISALLOWANCE: Mr Giles, pursuant to notice, moved—That the amendment to Regulation 9B of the Spirits Regulations as contained in Statutory Rules 1980, No. 384, made under the *Spirits Act* 1906, be disallowed.

Debate ensued.

Question—put and passed.

- 11 APPROPRIATION BILL (No. 3) 1980–81: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Willis, viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the provisions of the Bill, the House—

- (a) deplores the failure of the Government to fully spend appropriations in important areas of Government expenditure;
- (b) rejects the Government's claims that the improvements in economic growth that have occurred recently have been due to the effects of Government policies;
- (c) recognises that such modest recovery as has occurred is due to the failure of the Government to achieve particular policy objectives and to factors beyond the control of the Australian Government;
- (d) notes with alarm the gathering signs of an acute credit squeeze as exemplified by record and rising interest rates and shortages of home mortgage finance;
- (e) expresses its concern that severely restrictive monetary policies and a threatened tightening of fiscal policy will produce a renewed downturn in the rate of economic growth, and a further rise in unemployment, and
- (f) accordingly expresses its complete lack of confidence in Government economic policies"—

Debate resumed.

Debate adjourned (Mr Baume), and the resumption of the debate made an order of the day for a later hour this day.

12 APPROPRIATION BILL (No. 3) 1980-81: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Willis, viz.—That all words after “That” be omitted with a view to substituting the following words: “whilst not opposing the provisions of the Bill, the House—*

- 14 ADJOURNMENT: Mr Thomson (Minister for Science and Technology) moved—That the House do now adjourn.
Debate ensued.
Question—put and passed.
