TUESDAY, 26 MAY 1981

- 1 The House met at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Campbell, Mr Humphreys, Mr Hurford, Mr Johnson, Mr B. O. Jones, Mr J. L. McMahon and Mr Morris—from certain citizens praying that any proposal to sell Trans Australia Airlines be rejected.
 - Mr Bourchier and Mr J. L. McMahon—from certain citizens praying that the House recognise the importance of the hotel industry and that any proposal to increase the excise on beer be rejected.
 - Mr Bourchier—from certain citizens praying that the decision to cease funding for professional engineering education at the Bendigo College of Advanced Education, Vic., be reversed.
 - Mr E. C. Cameron—from certain citizens praying that any proposal to deny unemployment benefits to unemployed persons under 18 years of age be unconditionally withdrawn and that certain other action be taken in regard to unemployment benefits and employment policies.
 - Mr Campbell—from certain citizens praying that steps be taken to allow child-care expenses as a deductible item from taxpayers' assessable income.

 - Mr Cohen—from certain citizens praying that pensions and benefits be increased and adjusted quarterly and that greater taxation relief be given to pensioners and others on low incomes.
 - Mrs Darling—from certain citizens praying that supplementary assistance be indexed to increases in the cost of living by the same biannual process applied to increases in the pension.
 - Mrs Darling---from certain citizens praying that the decision to close the Rosemount Repatriation Hospital, Qld, be reversed.
 - Mrs Darling—from certain citizens praying that the recent decisions made with respect to tertiary education be rescinded and no steps be taken towards the re-introduction of fees for tertiary education.
 - Mr Dobie—from certain citizens praying that certain recommendations of the Law Reform Commission discussion paper on Privacy and Personal Information be rejected and some other means be found to protect children from the excessive abuse of some parents.
 - Mr Harris—from certain citizens praying that ex-servicewomen who volunteered for service in the 1939-45 war but were not sent to war zones be considered eligible for defence service home loans.

- Mr Howe—from certain residents of Victoria praying that adequate funds be made available for children's services so that family day care may be provided within the City of Northcote, Vic.
- Mr Humphreys—from certain citizens praying that legislation be introduced to require labelling of perfumes, cosmetics and toilet preparations to indicate any use of animal ingredients during manufacture.
- Mr Humphreys—from certain citizens praying that the public hospital funding arrangements and their impact on lower income groups be re-examined and funding to the States be increased.
- Mr Humphreys—from certain citizens praying that Service Pensions be extended to all merchant seamen who served in theatres of war.
- Mr Humphreys—from certain citizens praying that requests for export permits covering mineral sand products from Moreton Island, Qld, be refused.

- Mr Johnson—from certain citizens praying that funds be provided to acquire additional land for parks in the Botany Bay region, N.S.W., to augment the natural environment, and that steps be taken to minimise the incidence of oil spills in Botany Bay.
- Mr Jull—from certain citizens praying that post-secondary tuition fees not be re-introduced, visa charges upon private overseas students be removed, the decision to introduce a loans scheme be reversed and the Tertiary Education Assistance Scheme be increased and extended.
- Mrs Kelly—from certain electors of the Australian Capital Territory praying that steps be taken to adjust air fares to and from Canberra in line with the average increase of 7.4% or to compensate residents of Canberra for the massive increase in air fares.

- Mrs Kelly—from certain residents of the Australian Capital Territory praying that rodeos be banned within the Australian Capital Territory.
- Mr Kent—from certain residents of the Northern Territory praying that the offer of Darwin or any other location as a base or depot for American B-52 bombers be withdrawn and any request by the United States Government for the use of bases in Australia be rejected.
- Mr Kerin—from certain citizens praying that funds be provided to enable effluent to be piped from the Glenfield Sewerage Treatment Works to Malabar, N.S.W., and that certain other actions be taken to allow the Georges River to be cleaned up.

- 6 MEMBERS OF PARLIAMENT—SPONSORED TRAVEL: Mr Hayden (Leader of the Opposition) moved—That this House is of the opinion that, in view of Rules 8 (b) and 8 (c) of paragraph 4.9 of the report *Public Duty and Private Interest*, viz.—

"8. An officeholder should not:

- (b) solicit or accept any benefit, advantage or promise of future advantage whether for himself, his immediate family or any business concern or trust with which he is associated from persons who are in, or seek to be in, any contractual or special relationship with government;
- (c) except as may be permitted under the rules applicable to his office, accept any gift, hospitality or concessional travel offered in connection with the discharge of the duties of his office.",

and the clear potential for the conclusion to be drawn that the honourable Member for Bowman and Senator Collard could be seen as transgressing those provisions by accepting free overseas travel from an unidentified business consortium, they should reject this offer forthwith.

Debate ensued.
