# WEDNESDAY, 27 MAY 1981

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Armitage, Mrs Child, Mr C. K. Jones, Mr J. L. McMahon, Mr Milton and Mr Mountford—from certain citizens praying that any proposal to sell Trans Australia Airlines be rejected.
  - Dr Blewett, Mrs Child and Mr West—from certain citizens praying that women's refuges, health centres and rape crisis centres be funded under special purpose grants administered federally under one Department and certain other actions be taken to ensure the continuing effectiveness of women's services.
  - Mrs Child and Mr Milton—from certain citizens praying that any proposal to legislate for the establishment of plant variety rights in Australia be rejected.
  - Mrs Child and Mr Street—from certain citizens praying that steps be taken to grant a service pension to ex-service personnel who did not serve overseas.
  - Mr Fisher and Mr Street—from certain citizens praying that any proposal to deny unemployment benefits to unemployed persons under 18 years of age be unconditionally withdrawn and that certain other action be taken in regard to unemployment benefits and employment policies.
  - Mr Humphreys and Mr McVeigh—from certain citizens praying that requests for export permits covering mineral sand products from Moreton Island, Qld, be refused.
  - Mr J. L. McMahon and Mr Porter—from certain citizens praying that the House recognise the importance of the hotel industry and that any proposal to increase the excise on beer be rejected.
  - Mr J. J. Brown—from certain electors of the Electoral Division of Parramatta praying that any proposal to increase the excise on beer in the 1981-82 Budget not be proceeded with.
  - Mrs Child—from certain citizens praying that sanitary products for women be brought under the scrutiny of the Australian Drug Evaluation Committee and certain other actions be taken in regard to the possible threat posed to the health of women by toxic shock syndrome.
  - Mr Connolly—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.
  - Mr Connolly—from certain citizens praying that section 79 (1) of the Family Law Act be amended to allow Family Courts to be made open to the public and to permit publication of the details of their proceedings, provided that the names of parties and other identifying information are prohibited from disclosure.

- Mr Dobie—from certain citizens praying that certain recommendations of the Law Reform Commission discussion paper on Privacy and Personal Information be rejected and some other means be found to protect children from the excessive abuse of some parents.
- Mr Fisher—from certain citizens praying that post-secondary tuition fees not be introduced, the Tertiary Education Assistance Scheme be extended to meet the financial needs of students, and certain other action be taken in relation to tertiary and adult education.
- Mr Fry—from certain citizens praying that the decision to sell the Belconnen Mall and the Canberra fruit and vegetable retail markets in the A.C.T. be rejected.
- Mr Hall—from certain citizens praying for the prohibition of oil exploration within the Great Barrier Reef region and that the entire region be declared a Marine Park.
- Mr Howe—from certain residents of Victoria praying that adequate funds be made available for children's services so that family day care may be provided within the City of Northcote, Vic.
- Mr Humphreys—from certain citizens praying that any proposal for a broad based indirect or value-added tax on goods and services be rejected.

- Mr Humphreys—from cerain cittizens praying that Service Pensions be extended to all merchant seamen who served in theatres of war.
- Mr Kerin—from certain citizens praying that the funding of women's health centres and rape crisis centres be increased.
- Mr McLean—from certain residents of Western Australia praying that steps be taken to formulate an airline policy providing for greater competition so that prices and service are determined by free market forces.
- Mr J. L. McMahon—from certain citizens praying that steps be taken to reintroduce a system of health care based on ability to pay and that access to health care be based on medical need.
- Mr Mildren—from certain residents of Ballarat, Vic., praying that a UHF relay facility be provided to improve television reception in Ballarat.
- Mr Morris—from certain citizens praying that realistic funding levels be introduced to maintain existing services offered by women's refuges and certain other actions be taken to ensure the continuing effectiveness of the women's refuge program.

24 Message from the Senate—Commonwealth Legal Aid Commission Amendment Bill 1981: Message No. 88, dated 26 May 1981, from the Senate was reported transmitting for the concurrence of the House a Bill for "An Act to amend the 'Commonwealth Legal Aid Commission Act 1977'".

Bill read a first time.

Mr Viner (Minister representing the Attorney-General) moved—That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

25 INCOME TAX LAWS AMENDMENT BILL 1981: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate having been resumed by Mr Willis-

Adjournment negatived: It being 10.30 p.m.—The question was proposed—That the House do now adjourn.

Mr Wilson (Minister for Home Affairs and Environment) requiring the question to be put forthwith without debate—

Question-put and negatived.

- Mr Willis moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House notes with concern that:
  - the introduction of several additional tax concessions raises serious questions as to the suitability of tax legislation as a means of extending assistance to particular interest groups;
  - (2) no reasons have been given to the Parliament for providing these concessions through the tax system rather than through the expenditure side of the Budget;
  - (3) these concessions, being in the form of deductions rather than rebates, are inequitable in that they provide most assistance to highest income earners and least assistance to low income earners;
  - (4) no costings have been provided to the Parliament by the Treasurer on the concessions, and
  - (5) the Government has not developed a national strategic crude oil storage policy and calls on it to establish such a policy with the objective of meeting the International Energy Agency's target for national crude oil storage of 90 days national consumption".

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

Clauses 1 to 7, by leave, taken together, and agreed to.

Clause 8-

Mr Willis moved the following amendment: Page 4, proposed sub-section 57AJ (2), after paragraph (e) add the following paragraph:

"(f) if the unit of property is a storage tank—the capacity of the tank does not exceed 25,000 litres.".
