1 The House met, at 2 p.m., pursuant to adjournment.

2 **ABSENCE OF MR SPEAKER:** The Clerk having informed the House that Mr Speaker (the Honourable Dr H. A. Jenkins) was absent on Parliamentary business overseas, the Chairman of Committees (the Honourable L. R. Johnson) took the Chair as Acting Speaker, and read Prayers.

3 **COMMISSION TO ADMINISTER OATH OR AFFIRMATION OF ALLEGIANCE TO MEMBERS:** Mr Acting Speaker announced that he had received from His Excellency the Governor-General the following Commission:

**GREETING:**

WHEREAS by section 42 of the Constitution of the Commonwealth of Australia it is provided, amongst other things, that every Member of the House of Representatives shall before taking his seat make and subscribe before the Governor-General, or some person authorised by him, an oath or affirmation of allegiance in the form set forth in the schedule to the Constitution:

NOW THEREFORE I, SIR NINIAN MARTIN STEPHEN, the Governor-General of the Commonwealth of Australia, hereby authorise you, during any absence of the Speaker, at Parliament House, Canberra, in the Australian Capital Territory, to administer the oath or affirmation of allegiance to such Members of the House of Representatives as have not already made and subscribed that oath or affirmation since their election or last election to the House of Representatives.

**9 BROADCASTING SYSTEM—DEVELOPMENT OF SATELLITE-RELATED SERVICES—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER:**
