  - Mr Carlton and Mr Hodgman—from certain citizens praying that regulations amending the Customs (Prohibited Imports) Regulations and Customs (Cinematograph Films) Regulations and the ordinance superseding the ACT Objectionable Publications Ordinance be disallowed and certain other action taken in relation to censorship matters.
  - Mr Adermann—from certain citizens praying that the decision to alter the ACT Classification of Publications Ordinance be abandoned.
  - Mr Adermann, Mr I. M. D. Cameron and Mr Miller—from certain citizens, and Mr Adermann—from T. Newell, in similar terms to the last preceding petition.
  - Dr Blewett—from certain citizens praying that religious and human rights persecution in the Soviet Union be condemned.
  - Dr Blewett—from certain citizens praying that Medicare be implemented in its original form.
  - Mr Blunt—from certain citizens praying that the existing national flag remain
