1 On which day, being the first day of the meeting of the Parliament for the despatch of business pursuant to a Proclamation (hereinafter set forth), Alan Robert Browning, Clerk of the House of Representatives, Lyndal McAlpin Barlin, Deputy Clerk, Ian Charles Harris, First Clerk Assistant and Lynette Simons, Serjeant-at-Arms, attending in the House according to their duty, the said Proclamation was read at the Table by the Clerk:

PROCLAMATION

NINIAN STEPHEN Governor-General By His Excellency the Governor-General of the Commonwealth of Australia

Whereas by section 5 of the Constitution of the Commonwealth of Australia it is provided, among other things, that the Governor-General may appoint such times for holding the sessions of Parliament as he thinks fit:

Now therefore I, Sir Ninian Martin Stephen, Governor-General of the Commonwealth of Australia, by this Proclamation appoint Monday, 14 September 1987 as the day for the Parliament of the Commonwealth to assemble for the despatch of business.

And all Senators and Members of the House of Representatives are hereby required to give their attendance accordingly at Parliament House, Canberra, in the Australian Capital Territory, at 11.00 o'clock in the morning on Monday, 14 September 1987.

2 MESSAGE FROM HIS EXCELLENCY'S DEPUTY BY THE USHER OF THE BLACK ROD: The following message was delivered by the Usher of the Black Rod:

HONOURABLE MEMBERS.

The Deputy of His Excellency the Governor-General desires your attendance in the Senate Chamber forthwith.

Accordingly Members of the House of Representatives went to the Senate Chamber, where the Deputy addressed the Members of both Houses as follows:

MEMBERS OF THE SENATE AND MEMBERS OF THE HOUSE OF REPRESENTATIVES:

His Excellency the Governor-General, not thinking fit to be present in person at this time, has been pleased to appoint me his Deputy to declare open the Parliament of the Commonwealth, as will more fully appear from the instrument which will now be read by the Clerk of the Senate.

The instrument was read as follows:

I, SIR NINIAN MARTIN STEPHEN, Governor-General of the Commonwealth of Australia, pursuant to section 126 of the Constitution of the Commonwealth of Australia and Clause IV of the Letters Patent dated 24 August 1984 relating to the office of Governor-General of the Commonwealth of Australia, hereby appoint SIR ANTHONY FRANK MASON, Chief Justice of Australia, to be my deputy within the Australian Capital Territory to declare open the Parliament of the Commonwealth at the time and place appointed by the Proclamation published in the Commonwealth of Australia Gazette on Friday, 14 August 1987.

The Deputy then said:

MEMBERS OF THE SENATE AND MEMBERS OF THE HOUSE OF REPRESENTATIVES:

I have it in command from His Excellency the Governor-General to let you know that, after Members of the Senate and Members of the House of Representatives shall have been sworn, the causes of His Excellency calling this Parliament will be declared by him in person at this place; and, it being necessary that a President of the Senate and a Speaker of the House of Representatives shall be first chosen, you, Members of the Senate, will proceed to choose some proper person to be your President, and you, Members of the House of Representatives, will retire to the place where you are to sit, and there proceed to the choice of some proper person to be your Speaker; and later this day you will respectively present the persons whom you shall so choose to His Excellency at such time and place as he shall appoint.

Justice Wilson will attend in the House of Representatives for the purpose of administering the oath or affirmation of allegiance to honourable Members of that House.

And thereupon Members of the House returned to their own Chamber, and, after an interval of some minutes—

- 3 DEPUTY TO ADMINISTER THE OATH OR AFFIRMATION OF ALLEGIANCE TO MEMBERS: The Honourable Sir Ronald Darling Wilson, KBE, CMG, a Justice of the High Court of Australia, having been ushered into the Chamber and conducted by the Serjeant-at-Arms to the Chair, handed to the Clerk at the Table an authority, which was read and is as follows:
 - I. SIR NINIAN MARTIN STEPHEN, Governor-General of the Commonwealth of Australia, pursuant to section 42 of the Constitution of the Commonwealth of Australia, hereby authorise SIR RONALD DARLING WILSON, a Justice of the High Court of Australia, to attend at the House of Representatives Chamber at Parliament House, Canberra, in the Australian Capital Territory, on Monday, 14 September 1987, forthwith after the opening of the Parliament of the Commonwealth at 11 o'clock in the morning of that day, and there and then to administer the oath or affirmation of allegiance to such Members of the House of Representatives as are present.

The Deputy retired.

6 ELECTION OF SPEAKER: Mr Charles, addressing himself to the Clerk, proposed to the House for its Speaker Mrs Child, and moved—That she do take the Chair of this House as Speaker, which motion was seconded by Ms Fatin.

Mrs Child informed the House that she accepted nomination.

Mr Peacock (Deputy Leader of the Opposition), addressing himself to the Clerk, proposed to the House for its Speaker Mr Dobie, and moved—That he do take the Chair of this House as Speaker, which motion was seconded by Mr P. S. Fisher.

Mr Dobie informed the House that he accepted nomination.

There being no further proposal-

Debate ensued.

The House proceeded to ballot; and the ballot being concluded, the Clerk reported the result, as follows:

Mrs Child was thereupon declared elected as Speaker, and Mr Charles and Ms Fatin conducted her to the Chair.

Mrs Child returned her acknowledgments to the House for the honour it had been pleased to confer upon her by choosing her to be its Speaker, and thereupon sat down in the Chair.

Then the Mace, which before lay under the Table, was laid upon the Table.

Mr Hawke (Prime Minister), Mr Howard (Leader of the Opposition), Mr Sinclair (Leader of the National Party of Australia), Mr Charles, Mr Peacock (Deputy Leader of the Opposition) and Mr Dobie congratulated Madam Speaker, who expressed her thanks.

7 PRESENTATION OF THE SPEAKER: Mr Hawke (Prime Minister) stated that he had ascertained it would be His Excellency the Governor-General's pleasure to receive the Speaker in the Library of the Parliament at 2.35 p.m.

And the sitting of the House having been suspended at 12.43 p.m. until 2.33 p.m.—

Madam Speaker, after resuming the Chair, went with Members of the House to attend His Excellency; and, having returned, Madam Speaker reported that she had presented herself to His Excellency the Governor-General as the choice of the House of Representatives as its Speaker and that His Excellency had been kind enough to congratulate her.

8 AUTHORITY TO ADMINISTER OATH OR AFFIRMATION OF ALLEGIANCE TO MEMBERS: Madam Speaker announced that she had received from His Excellency the Governor-General the following authority:

I, SIR NINIAN MARTIN STEPHEN, Governor-General of the Commonwealth of Australia, pursuant to section 42 of the Constitution of the Commonwealth of Australia, hearby authorise JOAN CHILD, Speaker of the House of Representatives, from time to time, at Parliament House, Canberra, in the Australian Capital Territory, to administer the oath or affirmation of allegiance to such Members of the House of Representatives as have not already made and subscribed that oath or affirmation since their election or last election to the House of Representatives.

- 12 LEADERSHIP AND WHIPS OF THE LIBERAL PARTY OF AUSTRALIA: Mr Howard, as Leader of the Opposition, informed the House that the Parliamentary Liberal Party had elected him as its Leader and Mr Peacock as its Deputy Leader. Mr E. C. Cameron and Mr Andrew had been appointed Opposition Whip and Deputy Opposition Whip, respectively.
- 13 LEADERSHIP AND WHIP OF THE NATIONAL PARTY OF AUSTRALIA: Mr Sinclair informed the House that the Parliamentary Party of the National Party of Australia had elected him as its Leader, Mr Lloyd as its Deputy Leader and Mr Hicks as its Whip.
- 14 PARLIAMENTARY PRESIDING OFFICERS AMENDMENT BILL 1987: Mr Hawke (Prime Minister) presented a Bill for an Act to amend the Parliamentary Presiding Officers Act 1965.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting.

- 15 HIS EXCELLENCY THE GOVERNOR-GENERAL'S SPEECH: Madam Speaker reported that the House had that day attended His Excellency the Governor-General in the Senate Chamber, when His Excellency was pleased to make a speech to both Houses of the Parliament. (Text of the speech appears in Hansard)
- 16 ADDRESS IN REPLY TO HIS EXCELLENCY THE GOVERNOR-GENERAL'S SPEECH:

 Mr Hawke (Prime Minister) moved—That a committee, consisting of Ms
 Crawford, Mr Kerr and the mover be appointed to prepare an Address in
 Reply to the speech delivered by His Excellency the Governor-General to both
 Houses of the Parliament and that the committee report at the next sitting.

 Question—put and passed.

Suspension of sitting: At 3.58 p.m., Madam Speaker left the Chair. Resumption of sitting: At 5 p.m., Madam Speaker resumed the Chair.

17 ELECTION OF CHAIRMAN OF COMMITTEES: Mr Punch moved—That Mr McLeay be appointed Chairman of Committees of this House, which motion was seconded by Mr Dubois.

Mr Braithwaite moved—That Mr Millar be appointed Chairman of Committees of this House, which motion was seconded by Mr D. M. Cameron.

There being no further proposal—

Debate ensued.

The House proceeded to ballot; and the ballot being concluded, Madam Speaker reported the result, as follows:

Mr McLeav was thereupon declared elected as Chairman.

Mr Hawke (Prime Minister), Mr Howard (Leader of the Opposition), Mr Sinclair (Leader of the National Party of Australia), Mr Punch, Mr Millar, Mr Dubois and Mr D. M. Cameron congratulated Mr McLeay, who made his acknowledgments to the House.

- 18 BUDGET SPEECH AND REPLY—TELEVISION COVERAGE: Mr Young (Leader of the House), by leave, moved—That this House authorises:
 - (1) the Speaker to make arrangements for the preliminary proceedings relating to the introduction of the Appropriation Bill (No. 1) 1987-88, all or part of the second reading speech of the Treasurer, and all or part of the reply to that speech by the Leader of the Opposition to be filmed by the Australian Broadcasting Corporation;
 - (2) the direct, live telecast of all or part of that film and the accompanying sound of the proceedings by any television station provided that a station telecasts both speeches live and gives approximately equal time to both speeches: and
 - (3) the use by any television station of any part of the filmed proceedings and accompanying sound in subsequent news, current affairs and documentary programs.

Debate ensued.

Question—put and passed.

- 19 DAY AND HOUR OF MEETING—ROUTINE OF BUSINESS: Mr Young (Leader of the House), by leave, moved—That:
 - (1) the House, at its rising, adjourn until tomorrow at 2 p.m.; and
 - (2) so much of the standing orders be suspended as would prevent the routine of business for the sitting tomorrow being as follows, unless otherwise ordered:
 - 1. Questions without notice.
 - 2. Presentation of papers.
 - 3. Ministerial statements, by leave.
 - 4. Presentation of petitions.
 - 5. Matter of public importance.
 - 6. Notices and orders of the day.

Debate ensued.

Question—put and passed.

20 DEATH OF THE RIGHT HONOURABLE SIR BILLY SNEDDEN: Mr Hawke (Prime Minister) referred to the death of the Right Honourable Sir Billy Snedden, and moved—That this House expresses its deep regret at the death on 27 June 1987 of the Right Honourable Sir Billy Mackie Snedden, KCMG, QC, a former Member of this House for the Division of Bruce from 10 December 1955 to 21 April 1983, a former Minister of the Crown, a former Leader of the Opposition, and a former Speaker of the House of Representatives, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his family in their bereavement.

And Mr Howard (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Leader of the National Party of Australia), Madam Speaker and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Ouestion—passed.

21 ADJOURNMENT AS A MARK OF RESPECT: Mr Hawke (Prime Minister), as a mark of respect to the memory of the late Sir Billy Snedden, then moved— That the House do now adjourn. Question—put and passed.

And then the House, at 7.03 p.m., adjourned until tomorrow at 2 p.m. in accordance with the resolution agreed to this day.
