 - (3) measures to reduce wastage, and an assessment of the relative effectiveness of those proposed measures.
- 3 FOREIGN AFFAIRS, DEFENCE AND TRADE—JOINT COMMITTEE—PROPOSED AMENDMENT OF RESOLUTION OF APPOINTMENT: Mr Young (Leader of the House), pursuant to notice, moved—
 - (1) That the resolution of appointment of the Joint Committee on Foreign Affairs, Defence and Trade be amended:
 - (a) by omitting "3 sub-committees" from paragraph (8) and substituting "4 sub-committees"; and
 - (b) by omitting paragraph (11) and substituting the following paragraph: "(11) That the quorum of a sub-committee be 3 members of that sub-committee.".
 - (2) That a message be sent to the Senate acquainting it of this resolution and requesting its concurrence.
