MAY IT PLEASE YOUR EXCELLENCY-

We, the House of Representatives of the Parliament of the Commonwealth of Australia, in Parliament assembled, beg to express our loyalty to our Most Gracious Sovereign, and to thank

Your Excellency for the Speech which you have been pleased to address to Parliament— And on the Amendment moved by Mr. Deakin, viz.:—That the following words be added to the Address :— "and to inform Your Excellency that the Government merits the censure of the House and the country for its failure to realize its national and constitutional obligations, for flagrant neglect of its duty to secure industrial peace and good order and to uphold the law within the Commonwealth; for its maladministration of public affairs and public departments, for its grossly partisan actions and appointments and its reckless irresponsibility in the financial affairs of the Commonwealth "

### Debate resumed.
